LEGAL DESCRIPTION

Situated in the State of Ohio, County of Richland, Township of Madison; being a part of the Northeast Quarter of Section 24, Township 21-North, Range 18-West, and being all of the lands conveyed to Carrie D. Jamieson by official record volume 1171, page 321, being more particularly described as follows:

Beginning for the same at an iron pipe found in the northeast corner of said Northeast Quarter, said iron pipe also being on the centerline of Grace Street-(60' R/W) and the **Place of Beginning** of the parcel described herein;

Thence, the following FOUR Courses:

- 1. **South 00 degrees 09 minutes 33 seconds West, 450.50 feet** along the east line of said Northeast Quarter to an iron pin found in the northeast corner of a parcel conveyed to Wayne F. and Barbara K. Riffe by official record volume 2485, page 215;
- 2. **North 89 degrees 34 minutes 50 seconds West, 134.39 feet** along the north line of said Riffe parcel to an iron pin found in the southeast corner of a parcel conveyed to Judy A. Friend by official record volume 2357, page 702;
- 3. **North 01 degrees 54 minutes 14 seconds West, 446.22 feet** along the east line of said Friend parcel to a 2" Magnail spike set on the aforementioned centerline of Grace Street, passing through an iron pin set for reference at 411.22 feet;
- 4. **North 88 degrees 38 minutes 55 seconds East, 150.50 feet** along said centerline of Grace Street to the **Place of Beginning**, containing 1.4657 acres (63,846.52 square feet), more or less, and subject to all legal highways, easements, leases, and use restrictions of record.

Bearings are based on an assumed meridian and are used to express angles only.

Iron pins set are 5/8" rebar with plastic cap stamped "Ramsey S-8396"
