LEGAL DESCRIPTION

Situated in the State of Ohio, County of Richland, Township of Madison; being a part of the Southeast Quarter of Section 14, Township 21-North, Range 18-West, being the lands conveyed to Gary L. Tolsty by official record volume 2082, page 509 of the Richland County Recorder's records, and being more particularly described as follows:

Commencing at a railroad spike found and accepted as marking the intersection of the centerline of Grace Street-(60' R/W) with the centerline of Parry Street-(60' R/W);

Thence, North 00 degrees 40 minutes 56 seconds West, 952.14 feet along the centerline of said Parry Street to a Magnail spike found;

Thence, North 00 degrees 20 minutes 05 seconds West, 287.67 feet continuing along said centerline of Parry street to a point being the northwest corner of a parcel conveyed to Billy J. and Lisa M. Duffey by official record volume, 1260, page 271, being referenced by an iron pipe found North 89 degrees 34 minutes 37 seconds East, 28.97 feet and being the **Place of Beginning** of the parcel herein described:

Thence, the following **FOUR** Courses:

- 1. North 00 degrees 20 minutes 05 seconds West, 60.03 feet continuing along said centerline of Parry street to a point being the southwest corner of a parcel conveyed to Robert A. & Mable M. Saunier by official record volume 54, page 871;
- 2. **North 89 degrees 30 minutes 18 seconds East, 206.27 feet** along the south line of said Saunier parcel to an iron pipe found on the west line of a parcel conveyed to The Kroger Company by official record volume 785, page 623, passing through an iron pipe found for reference at 30.00 feet;
- 3. **South 00 degrees 05 minutes 56 seconds East, 60.29 feet** along said west line of The Kroger Company parcel to an iron pipe found in the northeast corner of aforementioned Duffey parcel;

4. **South 89 degrees 34 minutes 37 seconds West, 206.02 feet** along the north line of said Duffey parcel to the **Place of Beginning** containing 0.2847 acres (12,401.67 square feet), more or less, and subject to all legal highways, easements, leases, and use restrictions of record.

Bearings are based on an assumed meridian and are used to express angles only.
