



## LEGAL DESCRIPTION

**Situated** in the Village of Bellville, being a part of the Southwest Quarter of Section 32, Washington Twp., T-20, R-18, Richland County, Ohio, and being a portion of a parcel conveyed to J.C. Gorman, Trustee by official record volume 2417, page 703 and being more particularly described as follows:

**Beginning** for the same a monument box found marking the intersection of the south line of said Quarter with the centerline of RIC-Bikeway (PB. 26, PG. 91);

Thence, the following SIX Courses:

- 1. South 89 degrees 28 minutes 51 seconds West, 460.77 feet along the south line of said quarter to an iron pin set;
- 2. North 15 degrees 24 minutes 20 seconds West, 911.33 feet, traversing the afore mentioned J.C. Gorman Trustee parcel to an iron pin set;
- 3. North 89 degrees 28 minutes 51 seconds East, 216.35 feet, traversing said J.C. Gorman Trustee parcel to an iron pin set on the easterly existing right of way line of the Richland County Bike Trail;
- 4. Along a non-tangential curve to the right with a radius of 4944.15 feet, a delta angle of 01 degrees 20 minutes 23 seconds an arc length of 115.61 feet, a chord bearing of South 31 degrees 30 minutes 55 seconds East, and a chord distance of 115.61 feet along said easterly existing right of way line to an iron pin found;
- 5. **South 30 degrees 50 minutes 44 seconds East, 905.56 feet** continuing along said easterly existing right of way line to an iron pin set on the south line of said quarter;
- 6. **South 89 degrees 28 minutes 51 seconds West, 38.23 feet** along said south line to the **Place of Beginning** and containing a total of 7.2465 Acres, more or less, of which 1.9594 acres are located within existing bike trail and highway right of way, resulting in a net area of 5.2871 acres, more or less, and subject to all legal highways, easements, leases, and use restrictions of record.

Bearings are based on an assumed meridian and are used to denote angular variations.

Iron pins set are 5/8" rebar with plastic cap stamped "McCartney S-7921"
