Boundary description of a 7751.673 square foot parcel

Situated in the City of Mansfield, County of Richland and State of Ohio:

Known as being the lands conveyed to Patricia D. Rentz in Volume 1051; Page 500 of Richland County Official Records and further bounded and described as follows:

Beginning at a 5/8 inch rebar with I.D. cap "Blunk" found on the northwesterly line of Forest Drive, (60 feet right of way), and known as the northeasterly corner of Lot 20494 of the consecutively numbered lots of the City of Mansfield;

THENCE WITH THE FOLLOWING SIX (6) COURSES:

- 1. **S** 33° 49' 28" W, 50.00 feet along the southeasterly line of Lot 20494 and the northwesterly line of Forest Drive to a capped rebar set, point being the southeasterly corner of Lot 20494 and the northeasterly corner of Lot 20493;
- 2. Thence along the southeasterly line of Lot 20493, the northwesterly line of Forest Drive and a curve to the right having a radius of **100.00** feet, an arc length of **5.00** feet, delta of **02° 51' 54"**, and a chord bearing of **S 35° 20' 39"** W for a chord distance of **5.00** feet to a capped rebar set;
- 3. **N 45° 38' 34" W, 148.63** feet along the Grantor's southwesterly line and parallel to the southwesterly line of Lot 20494 to a capped rebar set on the westerly line of Lot 20493 and the easterly line of Lot 20479;
- 4. **N 01° 17' 04" E, 6.76** feet along the Grantor's westerly line and the westerly line of Lot 20493 to a 1 inch iron pipe found and known as the northerly corner of Lot 20493 and the southwesterly corner of Lot 20494;

- 5. **N 08° 30' 35" E, 45.00** feet along the Grantor's westerly line, the westerly line of Lot 20494 and the easterly line of the lands conveyed to Dawsonridge Par & Pub, LLC. an Ohio Limited Liability Company, (O.R. V-2461, P-234), to a 5/8 inch rebar with I.D. cap "Craig" found and known as the northwesterly corner of Lot 20494;
- 6. **S 49° 55' 17" E, 170.15** feet along the Grantor's northeasterly line and the northeasterly line of Lot 20494 to the principal place of beginning and containing within said bounds **7751.673** square feet of land, more or less, of which 7008.109 square feet are contained in Lot 20494 and 743.564 square feet are contained in Part Lot 20493, but as one, and subject to all legal highways and easements of record.
