LEGAL DESCRIPTION

Situated in the City of Mansfield, County of Richland, State of Ohio and being part of Lot #11039 of the consecutively numbered lots in said city as recorded in plat volume 15, page 3, being a parcel conveyed to Kevin R. Kruer and Heather M. Tsavaris by official record volume 2063, page 465 of the Richland County Recorder's records, and being more particularly described as follows:

Commencing at the northeast corner of Lot 11039, at an iron pin found marking the westerly terminus of a curve located along the southerly existing right of way line of Edgewood Road-(60' R/W);

Thence, **South 88 degrees 14 minutes 23 seconds West, 142.20 feet**, along said southerly existing right of way line of Edgewood Road to a point referenced by an iron pin found South 78 degrees 24 minutes 33 seconds East, 0.46 feet, said point being the northwest corner of a parcel conveyed to Russell Kiser II, Trustee, or his successors in trust as restated in official record volume 1994, page 437 being the **Place of Beginning** of the parcel described herein;

Thence, the following FOURTEEN courses:

- 1. South 08 degrees 27 minutes 28 seconds East, 42.01 feet traversing said Lot #11039 along the west line of said Kiser parcel to an iron pipe found;
- 2. **South 11 degrees 06 minutes 04 seconds West, 72.11 feet** traversing said Lot #11039 along said west line to a point referenced by an iron pipe found South 11 degrees 06 minutes 04 seconds West, 12.10 feet;
- 3. North 78 degrees 53 minutes 56 seconds West, 3.51 feet, traversing aforementioned Kruer Tsavaris parcel with a new line to an iron pin set;
- 4. **North 19 degrees 23 minutes 55 seconds East, 13.02 feet** traversing said Kruer Tsavaris parcel with a new line to an iron pin set;
- 5. **North 29 degrees 39 minutes 24 seconds West, 5.21 feet** traversing said Kruer Tsavaris parcel with a new line to an iron pin set;
- 6. **North 03 degrees 52 minutes 25 seconds West, 2.59 feet** traversing said Kruer Tsavaris parcel with a new line to an iron pin set;
- 7. **North 12 degrees 38 minutes 34 seconds West, 10.61 feet** traversing said Kruer Tsavaris parcel with a new line to an iron pin set;
- 8. North 31 degrees 16 minutes 11 seconds East, 2.34 feet traversing said Kruer Tsavaris parcel with a new line to an iron pin set;
- 9. **North 79 degrees 48 minutes 58 seconds East, 7.32 fee**t traversing said Kruer Tsavaris parcel with a new line to an iron pin set
- 10. **North 04 degrees 57 minutes 12 seconds East, 13.98 feet** traversing said Kruer Tsavaris parcel with a new line to an iron pin set;
- 11. North 19 degrees 17 minutes 22 seconds East, 16.60 feet traversing said Kruer Tsavaris parcel with a new line to an iron pin set;
- 12. **North 07 degrees 40 minutes 30 seconds West, 37.76 feet** traversing said Kruer Tsavaris parcel with a new line to an iron pin set;

- 13. **North 06 degrees 11 minutes 09 seconds West, 11.55 feet** traversing said Kruer Tsavaris parcel with a new line to a point on the aforementioned south right of way line of Edgewood Road, the north line of Lot # 11039, said point being referenced by an iron pin found North 89 degrees 58 minutes 44 seconds East, 3.52 feet;
- 14. **North 88 degrees 14 minutes 23 seconds East, 3.07 feet** along said south right of way line, said north line of Lot # 11039 to the **Place of Beginning**, and containing 0.0099 of an acre (430.64 square feet), more or less, and subject to all legal highways, leases, servitudes, use restrictions, and easements of record.

Bearings are based on an assumed meridian and are used to express angles only.
