DESCRIPTION 0.9849 ACRE

Situated in the State of Ohio, County of Richland, Township of Plymouth, being part of the Southeast Quarter of Section Eighteen (18), Township Twenty-three (23), Range Nineteen (19) and being a 1 acre parcel now or formerly owned by John L. Donnersbach as recorded in Official Record Volume 2784, Page 619 and being more particularly described as follows;

Commencing at a railroad spike found marking the southeast corner of the southeast quarter of Section 18, said railroad spike also marking the intersection of State Route 61 (Shelby Plymouth Road) (60 feet in width) and Dinninger Road (T.H. 62);

Thence North 00°04'29" East, 1323.16 feet with the east line of said quarter and the centerline of Shelby Plymouth Road to the **POINT OF BEGINNING** for the parcel herein described being referenced by a Rebar with cap stamped "Lutz 6758" found North 88°21'02" West, 30.00 feet, said point also marking the northeast corner of lands now or formerly owned by Orva E. and Dee Dee L. Dawson as recorded in Official Record Volume 2721, Page 397;

Thence with the following Four (4) courses;

- 1. North 88°21'02" West, 370.00 feet with the north line of said Dawson lands to a 8" dia. wood post found;
- 2. North 00°04'29" East, 116.00 feet to a 6" dia. wood post found;
- South 88°21'02" East, 370.00 feet to a point in the east line of said quarter and the centerline of said State Route 61, passing through a 5/8" rebar with cap stamped "Weigler 7747" set for reference;
- 4. South 00°04'29" West, 116.00 feet with the east line of said quarter and centerline of State Route 61, to the point of beginning, containing 0.9849 acre, being subject to all legal easements, restrictions and rights-of-way now on record.

Bearings are based on survey file AA-109 of the Richland County Tax Map Records, and are used to express angles only.
