

SURVEY DESCRIPTION PARCEL "A"

LOTS #11019-#11027, O.L. 230, PART O.L. 231 O.L. 37 S.D. 2, AND VACATED STREET CITY OF MANSFIELD, RICHLAND COUNTY, OHIO

Situated in the City of Mansfield, County of Richland, State of Ohio and being known as Lots #11019-#11027, O.L. 230, Part O.L. 231, O.L. 37 S.D. 2 and Vacated Street in said city and being more particularly described as follows:

Beginning for the same at an iron pin set marking the southeast corner of Lot #11027, Thence, South 87 degrees 53 minutes 00 seconds West with the south line of said lot and the westerly prolongation thereof 455.41 feet to an iron pin set marking the southwest corner of Lot #11019;

Thence, North 00 degrees 18 minutes 35 seconds West with the west line of said lot 165.00 feet to an iron pin set on the northwest corner of said lot;

Thence, North 87 degrees 53 minutes 25 seconds East with the north line of said lot 8.31 feet to an iron pin set;

Thence, North 00 degrees 01 minute 33 seconds East 68.08 feet to an iron pin set;

Thence, South 87 degrees 53 minutes 25 seconds West 53.02 feet to an iron pin set on the west line of Outlot 231;


Thence, North 00 degrees 01 minute 33 seconds East with the west line of said Outlot and the northerly prolongation thereof 674.63 feet to a point, referenced by an iron pin found on a bearing of South 87 degrees 40 minutes 47 seconds West and at a distance of 2.07 feet, said point marking the northwest corner of Outlot 37 S.D. 2;

Thence, North 87 degrees 40 minutes 47 seconds East with the north line of said Outlot 504.27 feet to an iron pin set marking the northeast corner of said Outlot;

Thence, South 00 degrees 13 minutes 19 seconds West with the east line of said Outlot and the southerly prolongation thereof passing through an iron pipe found at a distance of 43.48 and passing through an iron pin found at a distance of 760.07 feet, for a total distance of 909.67 feet to the place of beginning, containing 10.224 Acres, according to survey by Chad F. Craig P.S. 8195 on December 6, 2021, but subject to all easements, right of ways and highways of record.

Iron pins set are 5/8" rods with caps stamped "CRAIG 8195".

Bearings are based on State Plane Grid North NAD 83 (2011), Geoid 18A, Ohio North Zone and are intended to be used for angular determination only.

PART OUT LOT #231 CITY OF MANSFIELD, RICHLAND COUNTY, OHIO

Situated in the City of Mansfield, County of Richland, State of Ohio and being known as part Out Lot #231 and being more particularly described as follows:

Beginning for the same at an iron pin set marking the northwest corner of Lot #11019, the same being a corner of Lot #21914, Thence, South 88 degrees 02 minutes 25 seconds West 44.70 feet to a drill hole set in concrete on an east line of Lot #21914;

Thence, North 00 degrees 01 minute 33 seconds East with said east line 67.97 feet to an iron pin set;

Thence, North 87 degrees 53 minutes 25 seconds East 53.02 feet to an iron pin set;

Thence, South 00 degrees 01 minute 33 seconds West 68.08 feet to an iron pin set on the north line of Lot #11019;

Thence, South 87 degrees 53 minutes 25 seconds West 8.31 feet to the place of beginning, containing 3604 square feet, according to survey by Chad F. Craig P.S. 8195 on December 6, 2021 but subject to all easements, right of ways and highways of record.
