# LEGAL DESCRIPTION PARCEL A

### PART NW QUARTER SECTION 36 T-22 N, R-18 W WELLER TOWNSHIP RICHLAND COUNTY, OHIO

**Situated** in the Township of Weller, County of Richland, State of Ohio; being a part of the Northwest Quarter of Section 36, Township 22 North, Range 18 West, and being a portion of the lands conveyed to Margaret Ann Gramly by official record volume 2738, page 543, and being more particularly described as follows:

**Commencing** at a railroad spike found and accepted as marking the northwest corner of said northwest quarter, the same being the northwest corner of said Gramly parcel;

Thence, South 01 degree 52 minutes 17 seconds East, 106.87 feet along the west line of said northwest quarter and the west line of said Gramly parcel to an iron pin set on the centerline of Osbun Road-(T.H. 262)(60' R/W), and being the Place of Beginning of the parcel herein described;

Thence, the following **FIVE** courses:

- 1. South 65 degrees 59 minutes 17 seconds East, 66.97 feet along said centerline of Osbun Road to an iron pin set;
- 2. Continuing along said centerline of Osbun Road with a curve to the right having a radius of 600.00 feet, an arc length of 167.02 feet, a delta angle of 15 degrees 56 minutes 58 seconds, a chord bearing of South 58 degrees 00 minutes 48 seconds East and a chord distance of 166.48 feet to an iron pin set;
- 3. South 50 degrees 02 minutes 19 seconds East, 89.16 feet continuing along said centerline of Osbun Road to a railroad spike found in the northeast corner of a parcel conveyed to John J. Stevens and Lisa R. Stevens by official record volume 350, page 547;

- 4. **South 89 degrees 44 minutes 48 seconds West, 265.10 feet** along the north line of said Stevens parcel to a point on the west line of aforementioned northwest quarter, passing through an iron pin found for reference at 46.64 feet and 251.34 feet;
- 5. North 01 degree 51 minutes 19 seconds West, 173.97 feet to the Place of Beginning, and containing 0.6042 acres (26,319.35 sq. ft.), more or less, and subject to all legal highways, easements, leases, and use restrictions of record.

Bearings are relative to the Ohio State Plane Coordinate System NAD83(2011), Ohio North Zone as determined from GPS observations made in December 2013 and are for the purpose of determining directional variations.

Iron pins set are 5/8" diameter rod with plastic cap stamped "Ramsey S-8396".

PART NW QUARTER SECTION 36
PART NE QUARTER SECTION 35
T-22 N, R-18 W
WELLER TOWNSHIP
RICHLAND COUNTY, OHIO

Situated in the Township of Weller, County of Richland, State of Ohio; being a part of the Northeast Quarter of Section 35, a part of the Northwest Quarter of Section 36, Township 22 North, Range 18 West, and being a portion of the lands conveyed to John J. and Lisa R. Stevens by official record volume 2286, page 151, and being more particularly described as follows:

**Commencing** at a railroad spike found and accepted as marking the northwest corner of said northwest quarter;

Thence South 01 degree 51 minutes 19 seconds East, 603.79 feet along the west line of said northwest quarter to a point referenced by an iron pin set, South 84 degrees 57 minutes 49 seconds West, 3.04 feet therefrom, and being the Place of Beginning of the parcel herein described;

Thence, the following **SEVEN** courses:

- 1. North 84 degrees 57 minutes 49 seconds East, 149.82 feet traversing aforementioned Stevens parcel to an iron pin set;
- 2. North 53 degrees 10 minutes 52 seconds East, 283.43 feet traversing said Stevens parcel to an iron pin found;
- 3. North 74 degrees 57 minutes 46 seconds East, 36.62 feet to a railroad spike found on the centerline of Osbun Road-(T.H. 262)(60'R/W);
- 4. South 01 degree 51 minutes 11 seconds East, 178.23 feet along a west line of a parcel conveyed to Glennis D. and Arlene Porter by official record volume 284, page 722 to an iron pin found in an interior corner thereof;

- 5. South 74 degrees 56 minutes 50 seconds West, 429.73 feet along a north line of said Porter parcel to an iron pin found on the west line of aforementioned northwest quarter;
- 6. North 03 degrees 08 minutes 31 seconds West, 97.10 feet along an east line of said Porter parcel to an iron pin set;
