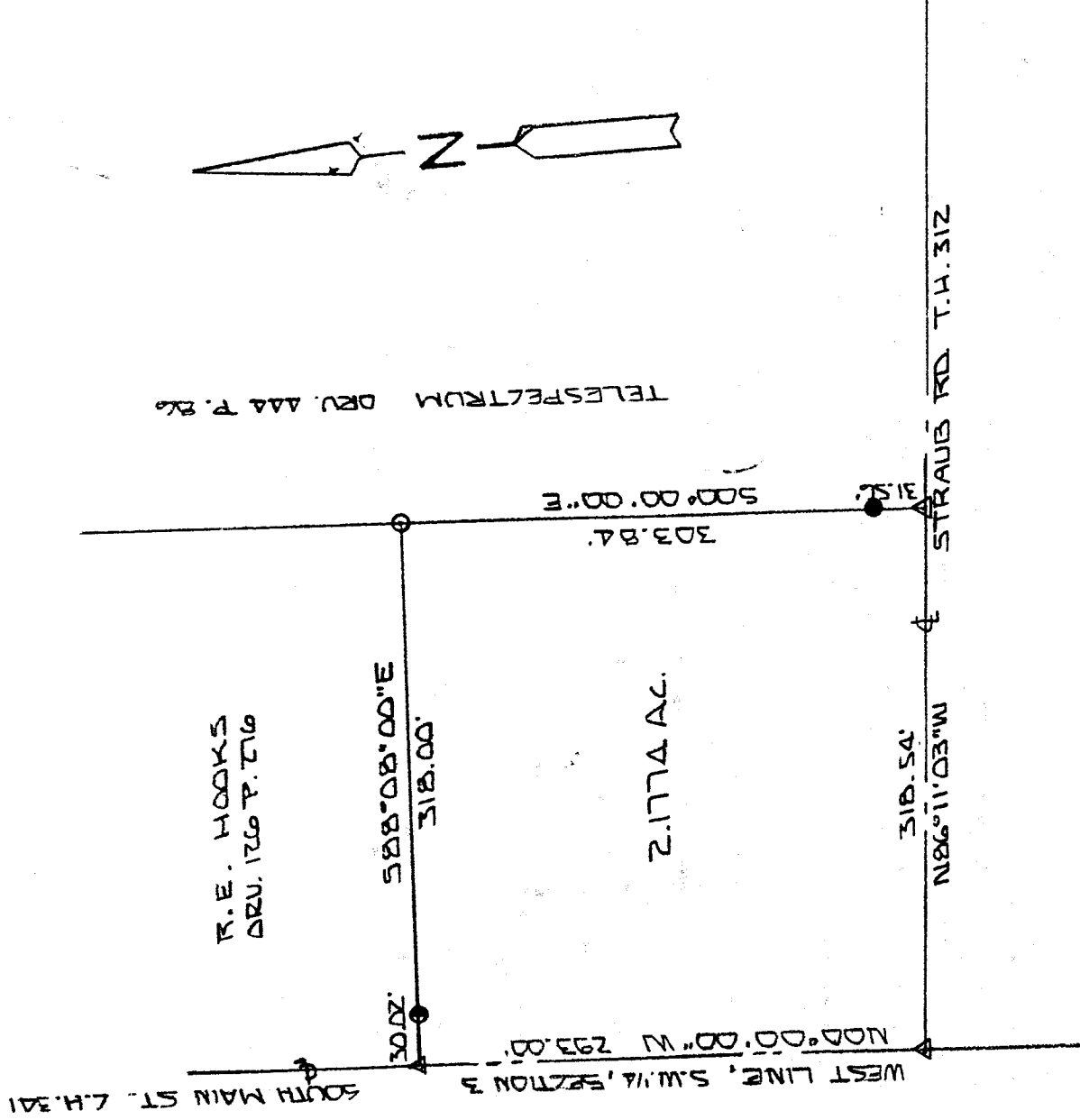

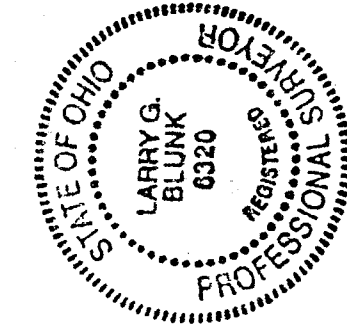

Located in the Township of Washington, County of Richland, State of Ohio and being a part of the Southwest Quarter of Section 3, Township 20, Range 18 and more particularly described as follows:

Beginning at a pk nail set on the west line of the Southwest Quarter of Section 3 with its intersection with the centerline of Straub Rd. T.H. 312.

Thence N 00 degrees 00' 00" W along the west line of the Southwest Quarter of Section 3, said line also being the centerline of South Main St. C.H. 341, a distance of 293.00 feet to a pk nail set.

Thence S 88 degrees 08' 00" E passing thru an iron pin found at 30.02 a distance of 318.00 feet to an iron pin set.

Thence S 00 degrees 00' 00" E passing thru an iron pin found at 272.28 feet a total distance of 303.84 feet to a pk nail set in the centerline of Straub Rd. T.H. 312.

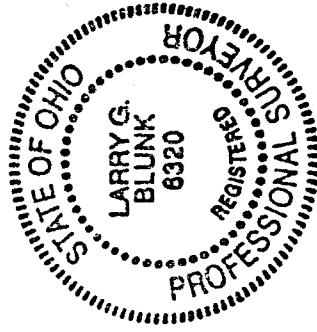
