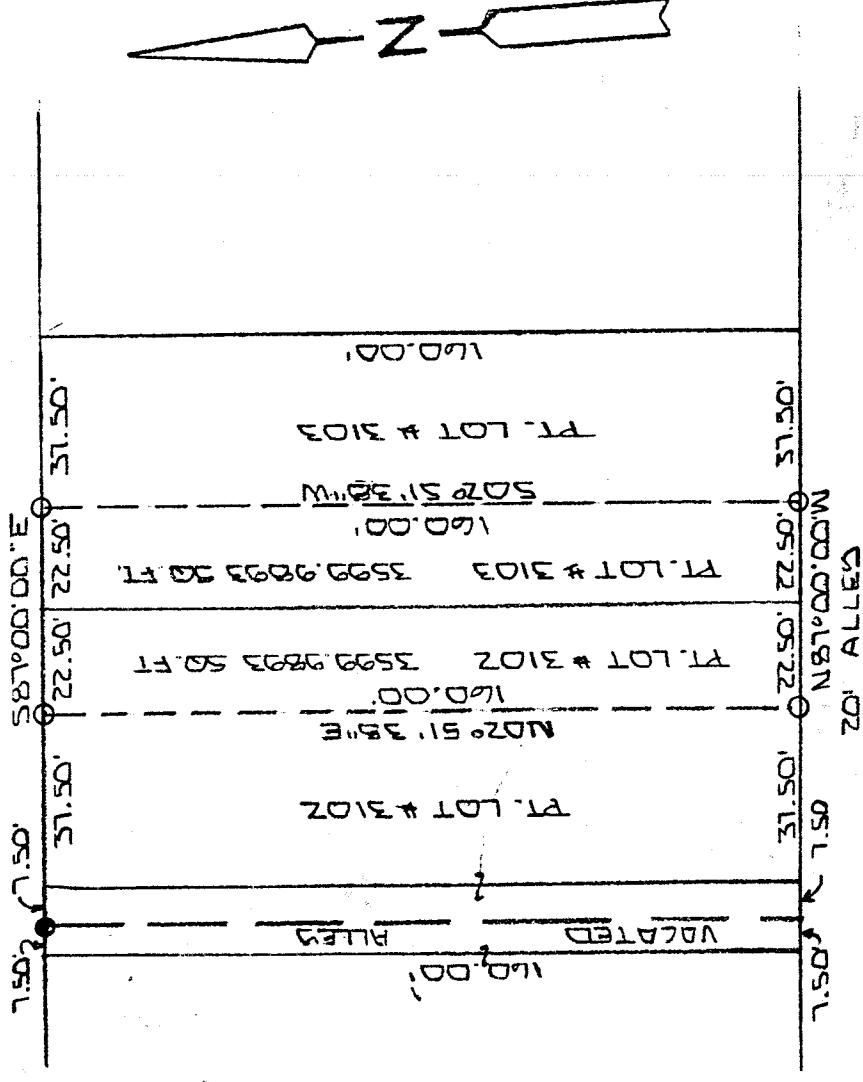

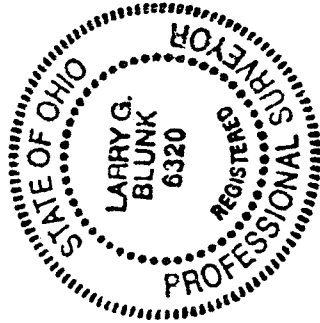

Located in the City of Mansfield, County of Richland, State of Ohio and being a part of Lot Numbers 3102 and 3103 as recorded in Volume 4, Page 48 of the Richland County Plat Records and more particularly described as follows:

Beginning at the Northeast Corner of Lot Number 3102, referenced by an iron pin set N 87 degrees 00' 00" W - 22.50 feet.

Thence S 87 degrees 00' 00" E along the north line of Lot Number 3103 a distance of 22.50 feet to an iron pin set.

Thence S 02 degrees 51' 38" W a distance of 160.00 feet to an iron pin set on the south line of Lot Number 3103.

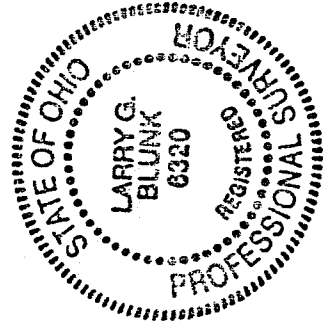
Thence N 87 degrees 00' 00" W along the south line of Lot Numbers 3103 and 3102 a distance of 45.00 feet to an iron pin set.

Thence N 02 degrees 51' 38" E a distance of 160.00 feet to an iron pin set on the north line of Lot Number 3102.

Thence S 87 degrees 00' 00" E along the north line of Lot Number 3102 a distance of 22.50 feet to the place of Beginning and containing 7199.9786 square feet in all of which 3599.9893 square feet are in a part of Lot Number 3102 and 3599.9893 square feet are in a part of Lot Number 3103 but subject to all legal highways also all easements of record.
