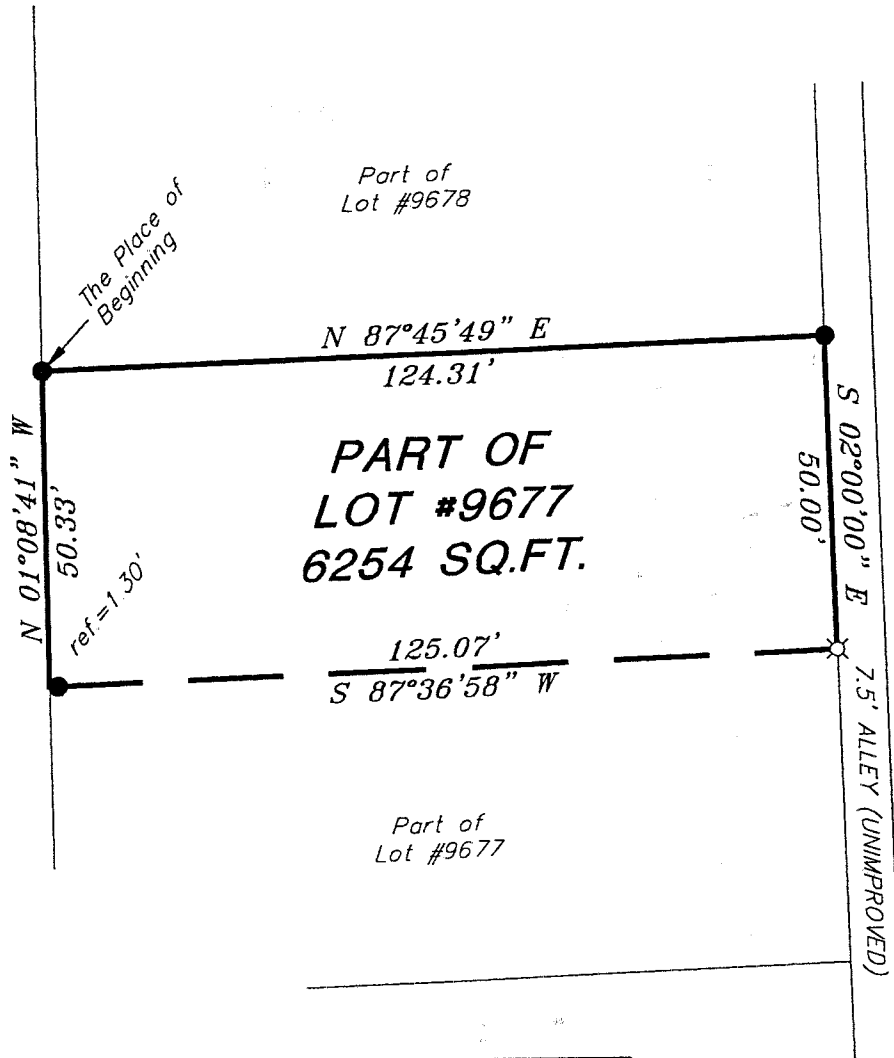
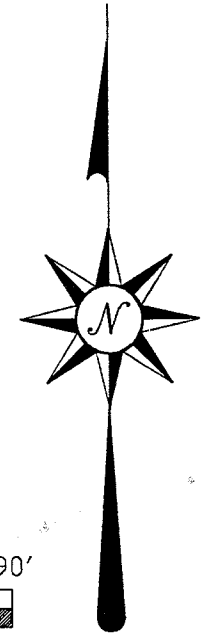

MARLOW ROAD 40' R/W



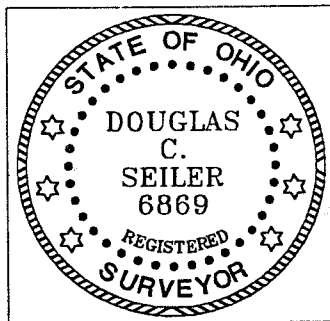

## SURVEY DESCRIPTION

PART OF LOT #9677  
CITY OF MANSFIELD, OHIO

Situated in the City of Mansfield, County of Richland, State of Ohio and being a part of Lot #9677 of the consecutively numbered lots in said city, more particularly described as follows:

Beginning for the same at an iron pin found and accepted as marking the northwest corner of said lot; Thence, North 87 degrees 45 minutes 49 seconds East with the north line of said lot, a distance of 124.31 feet to an iron pin found;

Thence, South 02 degrees 00 minutes 00 seconds East a distance of 50.00 feet to an iron pin set;

Thence, South 87 degrees 36 minutes 58 seconds West passing through an iron pin found for reference at 123.77 feet, a total distance of 125.07 feet;

Thence, North 01 degrees 08 minutes 41 seconds West with the west line of said lot, a distance of 50.33 feet to the place of beginning, containing 6254 square feet according to survey by Douglas C. Seiler, Professional Surveyor #6869 on May 30, 2002.
