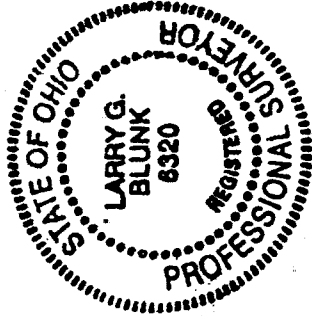
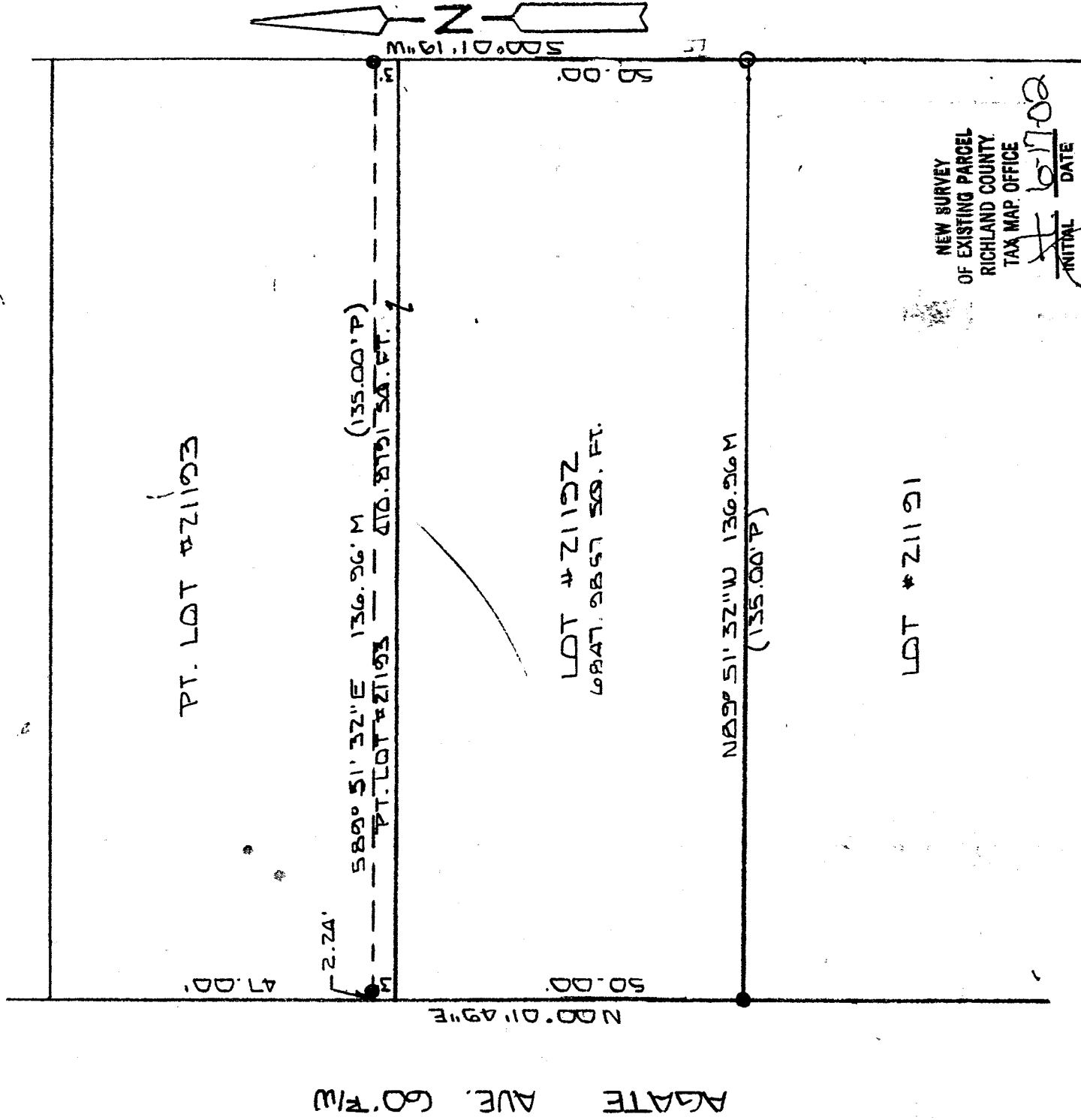


PLAT OF SURVEY FOR GALCO

Located in the City of Mansfield, County of Richland, State of Ohio and being Lot Number 21192 and a part of Lot Number 21193 as recorded in Volume 16, Page 7 of the Richland County Plat Records and more particularly described as follows:

Beginning at an iron pin found in the southwest corner of Lot Number 21192.

Thence N 00 degrees 01' 49" E along the west line of Lot Numbers 21192 and 21193 a distance of 53.00 feet to a point, referenced by an iron pin found S 89 degrees 51' 32" E - 2.24 feet.

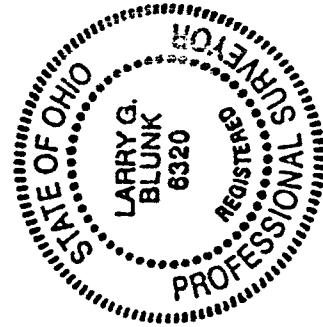
Thence S 89 degrees 51' 32" E a distance of 136.96 feet to an iron pin found on the east line of Lot Number 21193.

Thence S 00 degrees 01' 19" W along the east line of Lot Numbers 21193 and 21192 a distance of 53.00 feet to an iron pin set in the southeast corner of Lot Number 21192.

Thence N 89 degrees 51' 32" W along the south line of Lot Number 21192 a distance of 136.96 feet to the place of beginning and containing 7258.8648 square feet in all of which 6847.9857 square feet are in Lot Number 21192 and 410.8791 square feet in a part of Lot Number 21193 but subject to all legal highways also all easements of record.
