LEGAL DESCRIPTION

PARCEL 1

July 3, 2023

Situated in the Township of Springfield, County of Richland, State of Ohio and being part of the Northwest Quarter of Section 3 Township 21-North, Range 19-West and being a portion of the lands conveyed to Harold and Carolyn L. Stamper by official record volume 1843, page 398 and being more particularly described as follows:

Commencing at a railroad spike found and accepted as marking the southwest corner of said Quarter and being on the centerline of Rock Road-(C.R. 150)(60' R/W);

Thence, North 00 degrees 06 minutes 32 seconds East, 730.24 feet along the west line of said Quarter, said centerline of Rock Road, to a point referenced by an iron pin set North 89 degrees 05 minutes 43 seconds East, 25.00 feet therefrom, said point being the Place of Beginning of the parcel described herein;

Thence, the following FOUR courses:

- 1. North 00 degrees 06 minutes 32 seconds East, 831.69 feet continuing along the west line of said Quarter, said centerline of Rock Road to an iron pin set on the southerly line of a parcel conveyed to Pennsylvania Lines, LLC by official record volume 801, page 593;
- 2. North 71 degrees 53 minutes 28 seconds East, 1375.21 feet along said southerly line of Pennsylvania Lines, LLC parcel to an iron pin set in the northwest corner of a parcel conveyed to Amelia J., Michael C., William T. and Joseph E. Cotter by official record volume 2991, page 2735;
- 3. South 00 degrees 10 minutes 09 seconds East, 1238.42 feet along the west line of said Cotter parcel to an iron pin set;
- 4. **South 89 degrees 05 minutes 43 seconds West, 1312.49 feet** traversing aforementioned Stamper parcel to the **Place of Beginning**, and containing 31.126 acres, more or less, and subject to all legal highways, leases, servitudes, use restrictions, and easements of record.

Commencing at a railroad spike found and accepted as marking the southwest corner of said Quarter and being on the centerline of Rock Road-(C.R. 150)(60' R/W);

Thence, **North 00 degrees 06 minutes 32 seconds East, 502.00 feet** along the west line of said Quarter, said centerline of Rock Road to an iron pin set in the northwest corner of a parcel conveyed to Ronald E. and Keith E. Stamper by official record volume 2818, page 167 and being the **Place of Beginning** of the parcel described herein;

Thence, the following **FIVE** courses:

- 1. North 00 degrees 06 minutes 32 seconds East, 228.24 feet continuing along the west line of said Quarter, said centerline of Rock Road to a point;
- 2. North 89 degrees 05 minutes 43 seconds East, 1312.49 feet traversing aforementioned Harold and Carolyn L.
