Thence, South 64 degrees 25 minutes 36 seconds East with the north line of said lot 84.87 feet to an iron pin set;

Thence, South 18 degrees 42 minutes 37 seconds West 52.71 feet to an iron pin set on the north line of Lot #138;

Thence, South 89 degrees 50 minutes 54 seconds West with said north line 99.00 feet to an iron pin set on the northwest corner of said lot;

Thence, North 00 degrees 18 minutes 19 seconds West 105.02 feet to the place of beginning, containing a total of 8,609 square feet, of which 6,929 square feet are in Part Lot #406 and 1,680 square feet are in Part of Vacated Alley, according to survey by Chad F. Thence, North 00 degrees 18 minutes 19 seconds West with said west line 33.82 feet to an iron pin set marking the northwest corner of said lot;
