Situated in the Township of Weller, T-22N; R-18W, Southeast Quarter of Section 1 and Northeast Quarter of Section 12, County of Richland, and State of Ohio:

Known as being part of lands conveyed to Faith United Methodist Church of Richland County, Inc. in O.R.V. 2630; Page 486 of Richland County Official Records and further bounded and described as follows;

Commencing at a railroad spike found at the southeast corner of the Southeast Quarter of Section 1 also being in Mansfield-Adario Road (T.R. 242) ~ witnessed by a 5/8" rebar with I.D. cap marked "Seiler 6869." found at S 83°40'31" W, 30.17 feet;

Thence S 87°55'03" W, 217.91' along the south line of the Southeast Quarter of Section 1 also being the north line of the Northeast Quarter of Section 12 to 5/8" rebar with I.D. cap marked "S.J.L., INC." set in the east line of said Faith United Methodist Church lands and being the TRUE PLACE OF BEGINNING:

THENCE WITH THE FOLLOWING FIVE (5) COURSES:

- 1. S 00° 17' 29" W, 402.00 feet along the east line of said Faith United Methodist Church lands to a 5/8" rebar with I.D. cap marked "S.J.L., INC." set at a new division line;
- 2. S 87° 55' 03" W, 200.17 feet along a new division line to a 5/8" rebar with I.D. cap marked "S.J.L., INC." set;
- 3. N 00° 17' 29" E, 1,108.81 feet along a new division line to a point in the centerline of Ashland Shelby Road (S.R. 96) ~ witnessed by a 5/8" rebar with I.D. cap marked "S.J.L., INC" set at 30.34 feet, on line to the south, and passing through a 5/8" rebar with I.D. cap marked "S.J.L., INC" set at 402.00 feet in the south line of the Southeast Quarter of Section 1 also being the north line of the Northeast Quarter of Section 12;
- 4. S 81° 07' 49" E, 202.26 feet along the centerline of Ashland Shelby Road (S.R. 96) to a point ~ witnessed by a 5/8" rebar found at S 00° 17' 29" W, 30.34 feet,

S 00° 17' 29" W, 668.35 feet along the east line of said Faith United Methodist Church lands to the place of beginning and containing within said bounds 5.003 acres of land, more or less, of which 3.157 acres, more or less, lies within the Southeast Quarter of Section 1 and 1.846 acres, more or less, lies within the Northeast Quarter of Section 12 and subject to all legal highways and easements of record.
