DESCRIPTION 2.8047 ACRES

Situated in the State of Ohio, County of Richland, Township of Mifflin, being part of the Southwest Quarter of Section Twenty-two (22), Township Twenty-three (23), Range Seventeen (17) and being a 2.8 acre parcel now or formerly owned by Paul Blanton as recorded in Official Record Volume 1400, Page 807, and being more particularly described as follows;

Commencing at a rebar with cap stamped "C. Kerg RLS 7152" found marking the southeast corner of said quarter, said rebar being in the centerline of Harlan Road (County Highway 293);

Thence North 03°36'05" West, 43.00 feet with the east line of said quarter and the centerline of Harlan Road to a rebar with cap stamped "C. Kerg RLS 7152" found;

Thence North 61°25'41" West, 249.11 feet with the centerline of said Harlan Road to a railroad spike found;

Thence North 54°46'10" West, 124.85 feet with the centerline of said Harlan Road to a railroad spike found;

Thence North 31°40'50" West, 230.00 feet with the centerline of said Harlan Road to a 1/2" iron pipe found;

Thence North 40°40'11" West, 100.35 feet with the centerline of said Harlan Road to a point being referenced by a rebar with cap stamped "Weigler 7747" found South 64°20'00" West, 28.63 feet, said point being the **POINT OF BEGINNING** for the parcel herein described, said point also being the northeast corner of lands now or formerly owned by Ronald A. and Karen S. Dapper as recorded in Deed Volume 576, Page 110;

Thence with the following Five (5) courses;

- South 64°20'00" West, 496.76 feet with the north line of said Dapper lands and lands now or formerly owned by Michelle Spognardi Gorman, Trustee as recorded in Official Record Volume 2146, Page 63, to a rebar with cap stamped "Blunk 6320" found, said rebar also marking the southeast corner of lands now or formerly owned by Margaret M. Puckett and Jeanette Koehler as recorded in Official Record Volume 2881, Page 475;
- 2. North 00°14'59" East, 391.43 feet with the east line of said Puckett and Koehler lands to a point in the centerline of Peterson Road (T.H. 295), passing through a 1/2" iron pipe found at 353.50 feet;
- 3. North 76°24'39" East, 253.95 feet with the centerline of said Peterson Road to its intersection with the centerline of Harlan Road, being referenced by a rebar with cap stamped "Stevens 7152" found North 43°32'59" East, 13.50 feet;
- 4. South 38°00'05" East, 57.31 feet with the centerline of said Harlan Road to a point being referenced by a 1/2" rebar found North 49°57'34" East, 25.36 feet;
- 5. South 40°40'11" East, 251.52 feet with the centerline of Harlan Road, to the point of beginning, containing 2.8047 acres, being subject to all legal easements, restrictions and rights-of-way now on record.

Bearings are based on an assumed meridian, and are used to express angles only.
