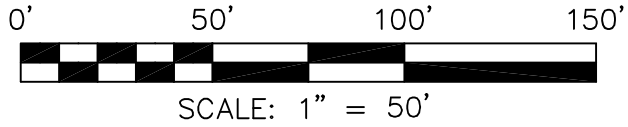

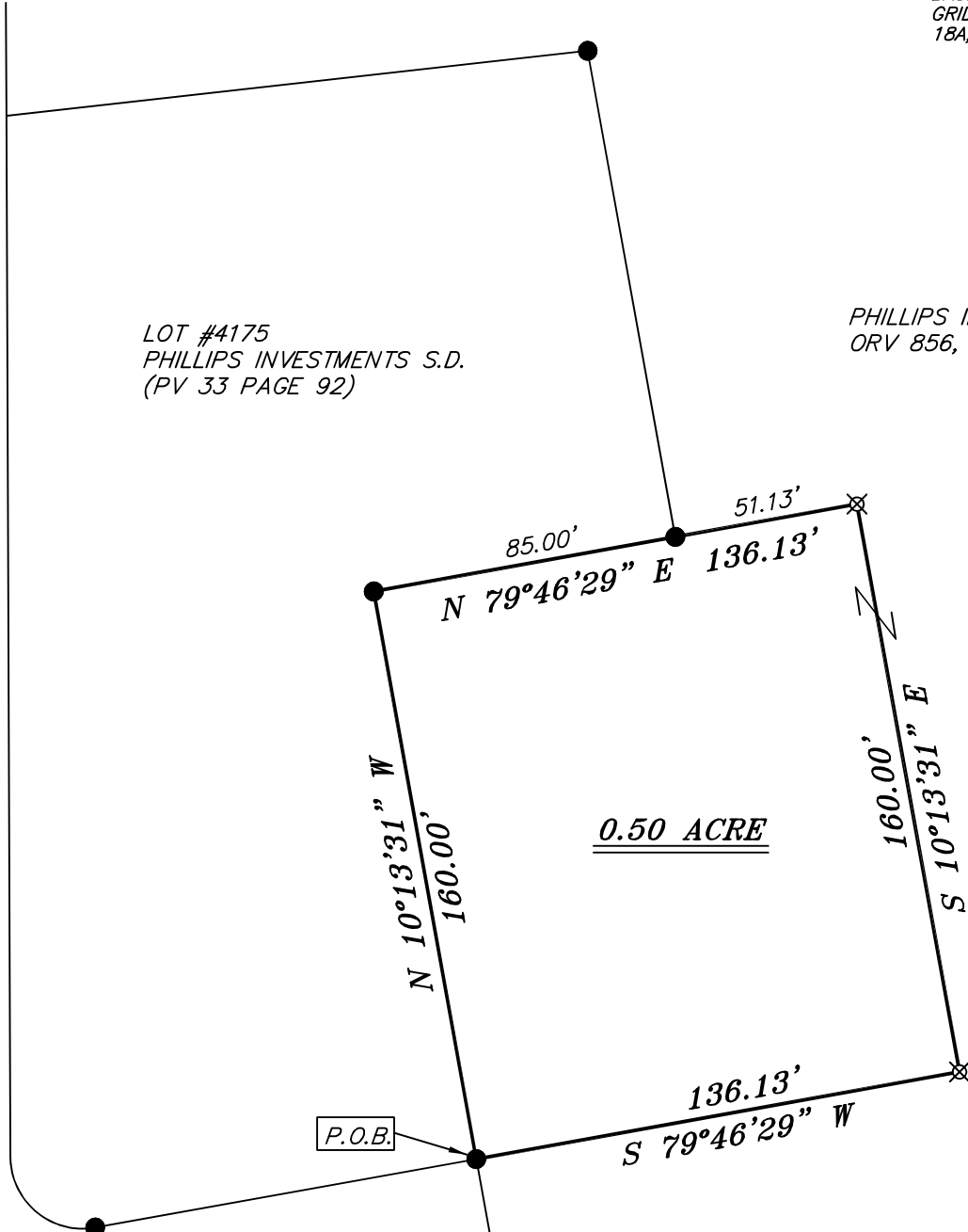


BASIS OF BEARING IS STATE PLANE

SURVEY DESCRIPTION

PART OF THE SE QUARTER OF SECTION 9
JACKSON TOWNSHIP, CITY OF SHELBY
RICHLAND COUNTY, OHIO

Situated in the Township of Jackson, City of Shelby, County of Richland, State of Ohio and being a part of the Southeast quarter of Section 9 of Township 22 North, Range 19 West, and being more particularly described as follows:

Beginning for the same at an iron pin found and accepted as marking a southeast corner of Lot #4175 in Phillips Investments Subdivision (PV 33, Page 92), Thence, North 10 degrees 13 minutes 31 seconds West with an easterly line of said lot 160.00 feet to an iron pin found;

Thence, North 79 degrees 46 minutes 29 seconds East with an easterly line of said lot and passing through an iron pin found at a distance of 85.00 feet, a total distance of 136.13 feet to an iron pin found;

Thence, South 10 degrees 13 minutes 31 seconds East 160.00 feet to an iron pin set;

Thence, South 79 degrees 46 minutes 29 seconds West 136.13 feet to the place of beginning, containing 0.50 acres according to a survey by Chad F. Craig P.S. #8195 for Seiler & Craig Surveying, Inc. on June 5, 2023, but subject to all easements, right of ways and highways of record.

Iron pins set are 5/8" rods with caps stamped "CRAIG 8195".

Bearings are based on State Plane Grid North, NAD 83 (2011), Geoid 18A, Ohio North Zone and are intended to be used for angular determination only.

The grantees, his heirs and assigns do hereby covenant and agree that the parcel of land described in this instrument or any portion thereof does not constitute a principal building site under applicable zoning and will not be conveyed by said grantees, heirs and assigns independent and separate from any adjoining or contiguous parcel fronting on a public highway or street.
