
PLAT OF BOUNDARY SURVEY FOR





DESCRIPTION PART LOT 695

Situated in the State of Ohio, County of Richland, City of Mansfield, being part of Lot 695 of the consecutively numbered lots in said City, and being more particularly described as follows;

BEGINNING at a mag nail set in asphalt, marking the northeast corner of Lot 695, also being the intersection of the south right-of-way line of West Fifth Street (60 feet in width) and the west right-of-way line of Weldon Avenue (20 feet in width);

Thence with the following Four (4) courses;

- 1. South 00°10'13" West, 47.78 feet with the east line of said Lot 695 and the west right-of-way line of Weldon Avenue to a 1" iron pipe found marking the southeast corner of Lot 695;
- 2. South 87°25'53" West, 56.16 feet with the south line of Lot 695 to a rebar with cap stamped "Little 5524" found;
- 3. North 01°59'33" West, 49.73 feet to a 5/8" rebar with cap stamped "Weigler 7747" set in the south right-of-way line of West Fifth Street;
- 4. North 89°24'41" East, 57.98 feet with the south right-of-way line of West Fifth Street, to the point of beginning, containing 2781.44 square feet, being subject to all legal easements, restrictions and rights-of-way now on record.

Bearings are based on an assumed meridian, and are used to express angles only.
