Situated in the Township of Weller, County of Richland, State of Ohio and being part of the Southwest Quarter of Section 14, Township 22-North, Range 18-West and being a portion of a record 31.52-acre parcel conveyed to Kenneth D. Boyce & Sharon A. Boyce by official record volume 219, page 951 and being more particularly described as follows:

Commencing at an iron pin in monument box found and accepted as marking the intersection of the centerline of Franklin Church Road-(C.R. 243) with the centerline of Chesrown Road-(T.R. 231)(Variable R/W);

Thence, North 87 degrees 01 minute 15 seconds West, 100.26 feet along the centerline of Chesrown Road to a monument box found, marking a point of curvature;

Thence, along a curve to the right with a radius of 347.25 feet, a delta angle of 11 degrees 20 minutes 19 seconds, an arc length of 68.72 feet, a chord bearing North 81 degrees 21 minutes 05 seconds West, and a chord distance of 68.61 feet, continuing along said centerline of Chesrown Road to a monument box found, marking a point of tangency;

Thence, North 75 degrees 40 minutes 56 seconds West, 336.20 feet continuing along the centerline of Chesrown Road to a monument box found, marking a point of curvature;

Thence, along a curve to the left with a radius of 587.65 feet, a delta angle of 12 degrees 01 minute 29 seconds, an arc length of 123.33 feet, a chord bearing North 81 degrees 41 minutes 39 seconds West, and a chord distance of 123.10 feet continuing along said centerline of Chesrown Road to a monument box found, marking a point of tangency;

Thence, North 87 degrees 42 minutes 24 seconds West, 194.77 feet continuing along said centerline of Chesrown Road to an iron pin in monument box found marking a point of deflection, said iron pin also being on the south line of a record 1.000-acre parcel conveyed to Kenneth D. Boyce & Sharon A. Boyce by official record volume 219, page 949;

Thence, **South 84 degrees 04 minutes 01 second East, 26.17 feet** along the south line of said record 1.000-acre Boyce parcel to a railroad spike found in the southeast corner thereof, and being the **Place of Beginning** for the parcel herein described;

Thence, the following FOUR courses:

- 1. **North 01 degree 04 minutes 01 second West, 222.82** feet along the east line of said record 1.000-acre Boyce parcel to an iron pin set in the northeast corner thereof, passing through an iron pin found for reference at 30.00 feet;
- 2. South 84 degrees 04 minutes 01 second East, 104.51 feet to an iron pin set;
- 3. **South 02 degrees 17 minutes 30 seconds West, 212.52 feet** to an iron pin set on the south line of the aforementioned record 31.52-acre Boyce parcel, and passing through an iron pin set for reference at 182.52 feet;
- 4. North 89 degrees 46 minutes 01 second West, 91.31 feet along the south line of said record 31.52-acre Boyce parcel to the Place of Beginning, containing 0.488 of an acre, more or less, and subject to all legal highways, leases, servitudes, use restrictions, and easements of record.
