

SURVEYOR'S DESCRIPTION FOR JOSEPH HOSTETLER

9.156 Acres

Situated in the Township of Worthington, County of Richland, State of Ohio, being part of the Southwest Quarter of Section 13, Township 21, Range 17, and being more particularly described as follows:

Commencing at a railroad spike found in the southeast corner of said Southwest Quarter, said railroad spike also being in the intersection of the centerline of S.R. 97 (60') and the centerline of McCurdy Road (C.H. 378)(44');

Thence S 88° 19' 45" W, 263.90 feet along the south line of said Southwest Quarter and along said centerline of S.R. 97 (60') to a point, said point being the southwest corner of a parcel of land conveyed the State Of Ohio by deed volume 195, page 543 and being referenced by an iron pin found N 01° 04' 11" W, 30.09 feet from said point and being the **true place of beginning**;

Thence with the following SIX courses:

- 1) S 88° 19' 45" W, 475.67 feet and continuing along said south line of said Southwest Quarter and along said centerline of S.R. 97 (60') to a point, said point being referenced by an iron pin set N 00° 57' 15" W, 25.05 feet from said point;
- 2) N 00° 57' 15" W, 568.81 feet to an iron pin set in the south line of a parcel of land conveyed to Deborah Sparks by official records volume 2201, page 533 and passing through previously an iron pin set at 25.05 feet;
- 3) N 88° 20' 30" E, 738.42 feet along said south line of said land of Deborah Sparks to a point being the southeast corner of said land, said point also being in the east line of said Southwest Quarter and being in said centerline of McCurdy Road (C.H. 378)(44') and passing through an iron pin found at 715.45 feet;
- 4) S 01° 04' 11" E, 487.54 feet along said east line of said Southwest Quarter and along said centerline of McCurdy Road (C.H. 378)(44') to a point being the northeast corner of said land of the State Of Ohio, said point being referenced by an iron pin found S 88° 19' 45" W, 30.00 feet from said point;
- 5) S 88° 19' 45" W, 263.90 feet along the north line of said land of the State Of Ohio to a concrete monument found in the northwest corner of said land and passing through an iron pin found at 30.00 feet;
- 6) S 01° 04' 11" E, 81.09 feet along the west line of said land of the State Of Ohio to the true place of beginning, passing through previously referenced iron pin found at 51.00 feet and containing 9.156 acres, more or less, and subject to all legal highways and easements of record.;

Thence S 88° 19' 45" W, 739.57 feet along the south line of said Southwest Quarter and along said centerline of S.R. 97 (60') to a point, said point being referenced by an iron pin set N 00° 57' 15" W, 25.05 feet from said point and being the **true place of beginning**;

Thence with the following FOUR courses:

- 1) S 88° 19' 45" W, 952.51 feet and continuing along said south line of said Southwest Quarter and along said centerline of S.R. 97 (60') to a point, said point being the southeast corner of a parcel of land conveyed to Forbes Farms LLC by official records volume 2902, page 759 being referenced by an iron pin set N 00° 33' 44" W, 30.33 feet from said point;
- 2) N 01° 07' 42" W, 569.00 feet along the east line of said land of Forbes Farms LLC to an iron pin found in the southwest corner of a parcel of land conveyed to Deborah Sparks by official records volume 2201, page 533;
- 3) N 88° 20' 30" E, 954.24 along the south line of said land of Deborah Sparks to an iron pin set;
- 4) S 00° 57' 15" E, 568.81 feet to the true place of beginning, passing through previously referenced iron pin set at 543.76 feet and containing 12.451 acres, more or less, and subject to all legal highways and easements of record.;
