DESCRIPTION 1.8205 ACRES

Situated in the State of Ohio, County of Richland, Township of Franklin, being part of the Northeast Quarter of Section Sixteen (16), Township Twenty-two (22), Range Eighteen (18) and being a 1.82 acre parcel now or formerly owned by Dustin A. and Brooke Smith as recorded in Official Record Volume 2654, Page 364 and being more particularly described as follows;

Commencing at the northeast corner of the northeast quarter of Section 16, said corner also being the intersection of the centerline of State Route 13 and the centerline of Eby Road (T.H. 230), being referenced by a 1/2" rebar found South 89°11'55" West, 29.82';

Thence South 00°14'52" West, 554.00 feet with the east line of said quarter and the centerline of Mansfield – Norwalk Road (State Route 13) to a point marking the northeast corner of said Smith lands, also being the **POINT OF BEGINNING** for the parcel herein described, being referenced by a 5/8" rebar with cap stamped "Weigler 7747" set for reference North 89°59'59" West, 30.45 feet;

Thence with the following Four (4) courses;

- South 00°14'52" West, 154.18 feet with the east line of said quarter and centerline of Mansfield-Norwalk Road to a point being referenced by a rebar with cap stamped "Weigler 7747" found North 89°07'45" West, 29.87 feet, said point also being the northeast corner of lands now or formerly owned by Seth A. and Christina Motter as recorded in Official Record Volume 2813, Page 297;
- North 89°07'45" West, 528.42 feet with the north line of said Motter lands to a 1/2" rebar with cap stamped "Weigler 7747" found in the east line of lands now or formerly owned by Jeff M. and Carol D. Roza as recorded in Official Record Volume 2735, Page 688;
- 3. North 00°28'24" East, 146.15 feet with the east line of said Roza lands to a 1/2" rebar with cap stamped "Weigler 7747" found marking the northwest corner of said Smith lands and the southwest corner of lands now or formerly owned by Chad E. Durbin as recorded in Official Record Volume 2720, Page 347;;
- 4. South 89°59'59" East, 527.82 feet with the south line of said Durbin lands, to the point of beginning, passing through a 5/8" rebar with cap stamped "Weigler 7747" set for reference at 497.37 feet, containing 1.8205 acres, being subject to all legal easements, restrictions and rights-of-way now on record.

Bearings are based on an assumed meridian, and are used to express angles only.
