



BEGINNING at a 1/2" iron pipe found marking the southeast corner of the said Lot 1172, said iron pipe also marking the intersection of the north right-of-way line of East Second Street (60 feet in width) and the west right-of-way line of Bentley Street (40 feet in width);

Thence with the following Four (4) courses;

- 1. North 89°25'27" West, 39.81 feet with the north right-of-way line of said East Second Street to a 1" iron pipe found marking the southwest corner of said Lot 1172;
- 2. North 00°16'26" West, 75.22 feet to a 5/8" rebar with cap stamped "Weigler 7747" set in the west line of Lot 1172;
- 3. South 89°29'22" East, 39.98 feet to a point in the west right-of-way line of said Bentley Street, passing through a 5/8" rebar with cap stamped "Weigler 7747" set for reference at 28.98 Feet;
- 4. South 00°08'12" East, 75.26 feet with the west right-of-way line of said Bentley Street to the point of beginning, containing 3001.43 Square feet, being subject to all legal easements, restrictions and rights-of-way now on record.
