

SURVEYOR'S DESCRIPTION FOR WALLACE & KATHLEEN TOWARD

4,041 SQ. FT.

Situated in the City of Mansfield, County of Richland, State of Ohio, being part of Lot 6926 as shown in plat book 9, page 12 and being more particularly described as follows:

Beginning at an iron pin found in the northeasterly corner of said Lot 6926, said iron pin also being in the southeasterly corner of O.L. 111 being in the west right of way line of Rowland Avenue (60');

Thence with the following **SEVEN** courses:

- S 01° 00' 00" E, 37.40 feet along the east line of said Lot 6926 also being along said west right of way line of Rowland Avenue (60') to a point being the northeast corner of a parcel of land conveyed to Club Exclusive LLC by official records volume 2999, page 4315 and passing through an iron pin set at 31.40 feet;
- 2) S 88° 39' 59" W, 144.00 feet along the north line of said land of Club Exclusive LLC to a point being the northwest corner of said land, said point also being in the west line of said Lot 6926 and passing through an iron pin set at 126.00 feet;
- N 01° 00' 00" W, 41.55 feet along said west line of said Lot 6926 to a point being the northwesterly corner of said Lot, said point also being in the southwesterly corner of O.L. 111 and being referenced by an iron pin found S 39° 24' 41" E, 0.21 feet from said point;
- 4) S 70° 41' 40" E, 6.31 feet along the northerly line of said Lot 6926 also being along the southerly line of said O.L. 111 to an iron pin found;
- S 65° 41' 40" E, 44.85 feet and continuing along said northerly line of said Lot 6926 also 5) being along said southerly line of said O.L. 111 to a drill hole set in concrete;
- N 83° 41' 40" E, 43.40 feet and continuing along said northerly line of said Lot 6926 also being along said southerly line of said O.L. 111 to a point and passing through an iron pin set at 41.90 feet;
- N 74° 30' 35" E, 56.10 feet and continuing along said northerly line of said Lot 6926 also 7) being along said southerly line of said O.L. 111 to the place of beginning and containing **4,041 square feet**, more or less, and subject to all legal highways and easements of record.

- 1) S 74° 30' 35" W, 56.10 feet along the southerly line of said O.L. 111 also being along the northerly line of said Lot 6926 to a point, said point being referenced by an iron pin set S 83° 41' 40" W, 1.50 feet from said point;
- 2) S 83° 41' 40" W, 43.40 feet and continuing along said southerly line of said O.L. 111 also being along said northerly line of said Lot 6926 to a drill hole set in concrete and passing through previously referenced iron pin set at 1.50 feet;
- 3) N 65° 41' 40" W, 44.85 feet and continuing along said southerly line of said O.L. 111 also being along said northerly line of said Lot 6926 to an iron pin found;
- 4) N 89° 27' 54" E, 138.08 feet to the place of beginning and containing 1,495 square feet.
