## PARCEL 1 DESCRIPTION OF 0.613 ACRE PARCEL JAMES HUNT

Situated in the State of Ohio, County of Richland, Township of Jefferson, lying in the Northeast Quarter of Section Seventeen (17), Township Nineteen (19), Range Eighteen (18), of an original tract conveyed to F.E. Hunt by deed of record in Official Record Volume 537, Page 550 (all references are to the records of the Recorder's Office, Richland County, Ohio) and being more particularly described as follows:

COMMENCING at a railroad spike found on the West line of the Northeast Quarter of said Section 17 in the centerline of Bollinger Road (T.H. 416);

thence North 89°13'12" East, with the centerline of said Bollinger Road, a distance of 795.79 feet to a railroad spike found;

thence North 87°51'20" East, with the centerline of said Bollinger, a distance of 564.23 feet to a railroad spike found at a Northeasterly corner of a deeded 41.97 acre tract conveyed to R.L. & J. Fry by deed of record in Official Record Volume 2758, Page 508, said point being the POINT OF BEGINNING for the tract herein described, referenced by a capped "Hanning PS 8568" iron pin found, South 02°33'44" East, a distance of 30.00 feet;

thence continuing North 87°51'20" East, with the centerline of said Bollinger Road, a distance of 226.00 feet to a railroad spike set on the Northwest corner of original tract conveyed to F.E. Hunt by deed of record in Official Record Volume 2605, Page 444;

thence South 02°33'44" East, with the West line of said original tract conveyed to F.E. Hunt by deed of record in Official Record Volume 2605, Page 444, a distance of 118.14 feet to an iron pin set on the North line of said tract conveyed to said deeded 41.97 acre tract;

thence with said deeded 41.97 acre tract the following two (2) courses and distances:

- 1. South 87°51'20" West, a distance of 226.00 feet to a square wood post found;
- 2. North 02°33'44" West, a distance of 118.14 feet to the POINT OF BEGINNING, containing 0.613 total acres of land, more or less;

thence North 89°13'12" East, with the centerline of said Bollinger Road, a distance of 795.79 feet to a railroad spike found;

thence North 87°51'20" East, with the centerline of said Bollinger Road, a distance of 790.23 feet to a railroad spike set at the Northeast corner of an original tract conveyed to F.E. Hunt by deed of record in Official Record Volume 537, Page 550, said point being the POINT OF BEGINNING for the tract herein described;

thence continuing North 87°51'20" East, with the centerline of said Bollinger Road, a distance of 158.00 feet to a railroad spike set at the Northwest corner of said of a 0.27 acre tract conveyed to S.W. & K.J.
