Thence, South 87 degrees 00 minutes 06 seconds West 113.86 feet to an iron pin set;

Thence, North 06 degrees 17 minutes 31 seconds East 245.80 feet to the place of beginning, containing a total of 13,810 square feet, of which 5,441 square feet are in Part Lot #107, 8,117 square feet are in Lot #108 and 252 square feet are in Part Vacated Sauder Drive, according to survey by Chad F. Craig P.S. 8195 on February 2, 2023, but subject to all easements, right of ways and highways of record.

Commencing at an iron pin found and accepted as marking the southeast corner of Lot #106, Thence, South 13 degrees 41 minutes 26 seconds West 30.00 feet to an iron pin found in Vacated Sauder Drive, Thence, South 06 degrees 17 minutes 31 seconds West 245.80 feet to an iron pin set and being the place of beginning for the parcel herein described;

Thence, South 06 degrees 17 minutes 31 seconds West 302.70 feet to an iron pin set on the south line of said Vacated Louetta Avenue;

Thence, South 86 degrees 57 minutes 19 seconds West with the south line of said Louetta Avenue 22.36 feet to an iron pin found;
