LEGAL DESCRIPTION

Situated in the City of Shelby, County of Richland, State of Ohio and being part of Lots 220 and 221 and part of vacated alleys of the consecutively numbered lots in said city, being the lands conveyed to Elizabeth C. Allwine by official record volume 803, page 66 and being more particularly described as follows:

Commencing at a drill hole set in concrete in the northeast corner of said Lot 221, also being on the south right of way line of South Street-(40' R/W)

Thence, **South 89 degrees 08 minutes 10 seconds West, 25.00 feet** along said south right of way line of South Street, the north line of said Lot 221 to a point found in the northwest corner of a parcel conveyed to Terri A. Fox by official record volume 2940, page 152, said point being the **Place of Beginning** of the parcel described herein and referenced by an iron pipe found North 22 degrees 49 minutes 34 seconds East, 0.43 feet therefrom;

Thence, the following SIX courses:

- 1. South 00 degrees 21 minutes 24 seconds West, 129.70 feet along the west line of said Fox parcel and along the west line of a parcel conveyed to Donald Shepherd Jr. by official record volume 2626, page 571 to a point in the southwest corner of said Shepherd parcel, being on the north line of a parcel conveyed to Brian L. Smith by official record volume 1629, page 736, said point being referenced by an iron pin found South 03 degrees 21 minutes 52 seconds West, 0.20 feet therefrom;
- 2. **South 89 degrees 33 minutes 43 seconds West, 55.59 feet** along the north line of said Smith parcel to an iron pin found in the northwest corner thereof, and being on the east right of way line of a 16 foot unimproved alley;
- 3. North 09 degrees 57 minutes 43 seconds East, 8.13 feet along said east right of way line of alley to an iron pin set in an interior corner of aforementioned Allwine parcel, also being on the north right of way line of a 16 foot unimproved alley;
- 4. **South 89 degrees 33 minutes 43 seconds West, 62.38 feet** along said north right of way line of alley to a point in the southeast corner of a parcel conveyed to David A. Bilka by official record volume 2394, page 272, passing through an iron pin set for reference at 59.38 feet;

- 5. North 00 degrees 21 minutes 35 seconds East, 120.84 feet along the east line of said Bilka parcel to an iron pipe found in the northeast corner thereof, also being on the aforementioned south right of way line of South Street;
- 6. **North 89 degrees 08 minutes 10 seconds East, 116.62 feet** along said south right of way line of South Street to the **Place of Beginning**, and containing a total of 14,578.86 square feet, more or less, of which 6,124.45 square feet are within Lot 220, 6,074.82 square feet are within part of Lot 221 and 2,379.59 square feet are within vacated alleys, and subject to all legal highways, leases, servitudes, use restrictions, and easements of record.

Bearings are based on an assumed meridian and are used to express angles only.

Iron pins set are 5/8" rebar with plastic cap stamped "Ramsey S-8396"
