Commencing at an iron pipe found and accepted as marking the northeast corner of said quarter, Thence, South 88 degrees 57 minutes 40 seconds West with the north line of said quarter 645.66 feet to a point referenced by an iron pipe found on a bearing of North 01 degree 37 minutes 35 seconds West and at a distance of 0.68 feet, said point marking the northwest corner of a parcel currently owned by N.T. Linger and J.D. Linger, Trustees (ORV 2110, Page 334), said point being the place of beginning of the parcel herein described;

Thence, South 01 degree 37 minutes 35 seconds East with the west line of said Linger parcel 663.73 feet to an iron pin set;

Thence, South 88 degrees 57 minutes 40 seconds West 330.49 feet to an iron pin set on the east line of a parcel currently owned by R. & K. Trustees (O.R.V. 607, Page 384 & O.R.V. 607, Page 390);

Thence, North 01 degree 13 minutes 27 seconds West with the east line of said parcel 663.70 feet to an iron pipe found on the north line of said quarter;

Thence, North 88 degrees 57 minutes 40 seconds East with said north line 325.83 feet to the place of beginning, containing 5.00 acres according to a survey by Chad F. Craig P.S. #8195 for Seiler & Craig Surveying, Inc. on October 5, 2023, but subject to all easements, right of ways and highways of record.

Commencing at an iron pipe found and accepted as marking the northeast corner of said quarter, Thence, South 88 degrees 57 minutes 40 seconds West with the north line of said quarter 645.66 feet to a point referenced by an iron pipe found on a bearing of North 01 degree 37 minutes 35 seconds West and at a distance of 0.68 feet, said point marking the northwest corner of a parcel currently owned by N.T. Linger and J.D. Linger, Trustees (ORV 2110, Page 334), Thence, South 01 degree 37 minutes 35 seconds East with the west line of said Linger parcel, passing through an iron pin set at 663.73 feet, at total distance of 926.62 feet to an iron pin set, the place of beginning of the parcel herein described;

Thence, South 01 degree 37 minutes 35 seconds East with the west line of said parcel 285.40 feet to an iron pin set marking the northeast corner of Lot #20 (Millsboro Meadows Block A, PV 20, Page 141);
