LEGAL DESCRIPTION

October 26, 2022

Situated in the Township of Monroe, County of Richland, State of Ohio, and being a part of the Southwest Quarter of Section 15, Township 22-North, Range 17-West and being a portion of the lands conveyed to Rick J. and Susan M. Foss, by deed volume 804, page 714 of the Richland County Recorder's records and being more particularly described as follows:

Commencing at a railroad spike found and accepted as marking the southwest corner of said Quarter and being the intersection of the centerline of Stout Road-(T.R. 363)(40' R/W) and the centerline of Gladden Road-(T.R. 98)(40' R/W);

Thence North 01 degree 12 minutes 03 seconds West, 992.39 feet along the west line of said Quarter, said centerline of Stout Road to a 2" Magnail spike set being the Place of Beginning of the parcel herein described;

Thence, the following FOUR courses:

- 1. **North 01 degree 12 minutes 03 seconds West, 276.08 feet** continuing along the west line of said Quarter, said centerline of Stout Road to a Magnail spike found in the southwest corner of a parcel conveyed to Charles A. Culler by official record volume 781, page 899;
- 2. North 89 degrees 11 minutes 17 seconds East, 789.08 feet along the south line of said Culler parcel to an iron pin set, passing through an iron pin found for reference at 20.00 feet;
- 3. **South 01 degree 12 minutes 03 seconds East, 276.08 feet** traversing aforementioned Foss parcel to an iron pin set;
- 4. **South 89 degrees 11 minutes 17 seconds West, 789.08 feet** traversing said Foss parcel to the **Place of Beginning**, passing through an iron pin set for reference at 769.08 feet, containing 5.0010 acres, more or less, and subject to all legal highways, easements, leases, and use restrictions of record.

Bearings are to an assumed meridian and are used to express angles only.

Iron pins set are 5/8" rebar with plastic cap stamped "Ramsey-S-8396"
