Thence, S 89° 03' 55" W, 172.53 feet along the section line, the Grantor's southerly line and with Noble Road to a point witnessed by a capped rebar set N 01° 13' 22" W, 25.00 feet and the principal place of beginning of the parcel herein described:

- 1. S 89° 03' 55" W, 400.00 feet along the section line, the Grantor's southerly line and with Noble Road to a point witnessed by a 3/4 inch steel rod found N 01° 13' 22" 26.19 feet;
