### Parcel "A"

January 22, 2024

**Situated** in the City of Mansfield, County of Richland, State of Ohio and being parts of Lots 16175, 16176, 16177, 16178, 16179, 16180, and 16181 of the consecutively numbered lots in said City, being a portion of a parcel conveyed to 1404 PAW, LLC by official record volume 2300, page 623, being more particularly described as follows:

**Beginning** for the same at an iron pin found in the northwest corner of said Lot 16181, also being a northwest corner of said 1404 PAW, LLC lands;

Thence, the following FOUR courses:

- 1. North 89 degrees 09 minutes 24 seconds East, 390.14 feet along a north line of said 1404 PAW, LLC lands, the north line of Lots 16181, 16180, 16179, 16178, 16177, 16176, and the north line of 16175 to an iron pin found in a northeast corner of said 1404 PAW, LLC lands, also being in a northwest corner of a parcel conveyed to Mansfield Buick GMC, Inc. by official record volume 2659, page 795;
- 2. **South 00 degrees 08 minutes 08 seconds West, 43.41 feet** along a west line of said Mansfield Buick GMC, Inc. parcel to an iron pin found in an existing interior corner thereof;
- 3. North 89 degrees 42 minutes 13 seconds West, 390.02 feet along a north line of said Mansfield Buick GMC, Inc. parcel and the westerly prolongation thereof to an iron pin set on the west line of the aforementioned Lot 16181, also being a west line of the aforementioned 1404 PAW, LLC lands;

**Situated** in the City of Mansfield, County of Richland, State of Ohio and being parts of Lots 16182, 16183, and 16184, of the consecutively numbered lots in said City, being a portion of a parcel conveyed to 1404 PAW, LLC by official record volume 2805, page 704, being more particularly described as follows:

**Commencing** at an iron pin found in the northeast corner of said Lot 16182, also being the northeast corner of said 1404 PAW, LLC parcel;

Thence, **South 00 degrees 01 minute 36 seconds West, 35.65 feet** along the east line of said Lot 16182, also being the east line of said 1404 PAW, LLC parcel, to an iron pin set, the **Place of Beginning** of the parcel herein described;

Thence, the following SIX courses:
