DESCRIPTION 15.0939 ACRES

Situated in the State of Ohio, County of Richland, City of Ontario, Township of Springfield, being part of the Northeast Quarter of Section Thirteen (13), Township Twenty-one (21), Range Nineteen (19) and being a 15.16 acre parcel now or formerly owned by William E. and Mary M. Schwartz, co-trustees, as recorded in Official Record Volume 1733, Page 873 and being more particularly described as follows;

BEGINNING at the southwest corner of the northeast quarter of Section 13, said point being referenced by a Charles Blosser concrete monument found North 00°27'21" East, 30.00 feet, said point being in the centerline of Longview Avenue;

Thence with the following Four (4) courses;

- North 00°27'21" East, 461.02 feet with the west line of said quarter parcel to a rebar with cap stamped "Richland Eng. 7209" found marking the northwest corner of the parcel herein described. said corner also being referenced by a Charles Blosser concrete monument found South 88°30'55" West, 9.13 feet;
- 2. North 88°30'55" East, 1395.10 feet to a wood fence post found, being referenced by a 5/8" rebar with cap stamped "Weigler 7747" set in the East line of the parcel herein described being South 00°48'21" East, 1.16 feet, passing through a Charles Blosser concrete monument at 1344.91 feet;
- 3. South 00°48'21" East, 478.37 feet with the west line of lands now or formerly owned by 65 Home Road Inv., Ltd as recorded in Official Record Volume 1107, Page 875 to a point in the centerline of Longview Avenue, passing through a 5/8" rebar with cap stamped "Weigler 7747" Set at 429.79
- South 89°13'55" West, 1405.15 feet with the south line of said quarter and centerline of Longview Avenue, to the point of beginning, containing 15.0939 acres, being subject to all legal easements, restrictions and rights-of-way now on record.

Bearings are based on an assumed meridian, and are used to express angles only.
