PARCEL 1 DESCRIPTION OF 0.516 ACRE PARCEL PATTY BARR

Situated in the State of Ohio, County of Richland, Township of Troy, lying in the Southwest Quarter of Section Twenty Eight (28), Township Twenty (20), Range Nineteen (19), of an original tract conveyed to D.M. & A.S. Barr by deed of record in Official Record Volume 2424, Page 560 (all references are to the records of the Recorder's Office, Richland County, Ohio) and being more particularly described as follows:

BEGINNING at a capped pin found at the Southwest corner of the Southwest Quarter of said Section 28 and the centerline of St. James Road (T.H. 36), referenced by an iron pin set, North 00°51'46" West, a distance of 20.00 feet;

thence North 00°51'46" West, with the West line of the Southwest Quarter of said Section 28, a distance of 385.03 feet to an iron pin set;

thence North 89°57'09" East, across said D.M. & A.S. Barr tract, a distance of 56.82 feet to a capped "Blunk" iron pin found at the Northwest corner of a tract conveyed to T.A. Bennett & P. Barr by deed of record in Official Record Volume 2394, Page 730;

thence South 01°19'10" East, with the West line of said T.A. Bennett & P. Barr tract, a distance of 385.07 feet to the South line of the Southwest Quarter of said Section 28 and the centerline of said St. James Road, passing by a capped "Blunk" iron pin found at a distance of 355.27 feet;

thence South 89°56'10" West, with the south line of the Southwest Quarter of said Section 28 and the centerline of said St. James Road, a distance of 59.88 feet to the POINT OF BEGINNING, containing 0.516 total acres of land, more or less;

PARCEL 2 DESCRIPTION OF 0.530 ACRE PARCEL PATTY BARR

Situated in the State of Ohio, County of Richland, Township of Troy, lying in the Southwest Quarter of Section Twenty Eight (28), Township Twenty (20), Range Nineteen (19), of an original tract conveyed to T.A. Bennett & P. Barr by deed of record in Official Record Volume 2394, Page 730 (all references are to the records of the Recorder's Office, Richland County, Ohio) and being more particularly described as follows:

COMMENCING at a capped pin found at the Southwest corner of the Southwest Quarter of said Section 28 and the centerline of St. James Road (T.H. 36), referenced by an iron pin set North 00°51'46" West, a distance of 20,00 feet;

thence North 89°56'10" East, with the South line of the Southwest Quarter of said Section 28 and the centerline of said St. James Road, a distance of 221.13 feet to a railroad spike set, said point being the POINT OF BEGINNING for the tract herein described, referenced by an iron pin set, North 01°06'43" West, a distance of 30.00 feet;

thence North 01°06'43" West, across said original tract conveyed to T.A. Bennett & P. Barr, a distance of 385.00 feet to an iron pin set on the South line of an original tract conveyed to D.M. & A.S. Barr by deed of record in Official Record Volume 2424, Page 560;

thence North 89°57'09" East, with said South line of said T.A. Bennett & P. Barr tract, a distance of 60.00 feet to a capped "E.G. Black" iron pin found at the Northwest corner of a 2.491 acre tract conveyed to J. Glazer & J. Hillenbrand by deed of record in Official Record Volume 2993, Page 2334;

thence South 01°06'43" East, with the West line of said 2.491 acre tract, a distance of 384.98 feet to a Mag Nail found on the South line of the Southwest Quarter of said Section 28 and the centerline of said St. James Road, passing by a capped "E.G. Black" iron pin found at a distance of 354.98 feet;

thence South 89°56'10" West, with the South line of the Southwest Quarter of said Section 28 and the centerline of said St. James Road, a distance of 60.00 feet to the POINT OF BEGINNING, containing 0.530 total acres of land, more or less;
