


SURVEYOR'S DESCRIPTION FOR LEWIS FAMILY RENTALS LLC

3,971 SQ. FT.

Situated in the City of Mansfield, County of Richland, State of Ohio, being part of Lots 7686 and 7687 of the consecutively numbered Lots in said City and being more particularly described as follows:

Beginning at an iron pin set in the southeast corner of said Lot 7687, said iron pin also being in the intersection of north right of way line of Davey Avenue (40') and west right of way line of Bartley Avenue (60');

Thence with the following FOUR courses:

- 1) N 86° 28' 54" W, 40.03 feet along the south line of said Lot 7687 and along said north right of way line of Davey Avenue (40') to an iron pin found in the southeast corner of a parcel of land conveyed to Steven Trouten by official records volume 2306, page 681;
- 2) N 03° 20' 37" E, 98.55 feet along the east line of said land of Steven Trouten to an iron pin found in the northeast corner of said land, said iron pin also being in the north line of said Lot 7686;
- 3) S 88° 30' 27" E, 40.01 feet along said north line of said Lot 7686 to a point being the northeast corner of said Lot, said point also being in said west right of way line of Bartley Avenue (60') and being referenced by an iron pin set S 03° 19' 07" W, 0.07 feet from said point;
- 4) S 03° 19' 07" W, 99.96 feet along the east line of said Lot 7686 and along the east line of said Lot 7687 also being along said west right of way line of Bartley Avenue (60') to the place of beginning, passing through previously referenced iron pin set at 0.07 feet and containing 3,971 square feet, more or less, of which 2,011 square feet are in part of Lot 7686, and 1,960 square feet are in part of Lot 7687 and subject to all legal highways and easements of record.

Basis of bearings: Survey F-4-145.

Iron pins set are 5/8" diameter rod with plastic cap stamped "Stevens 7052".
