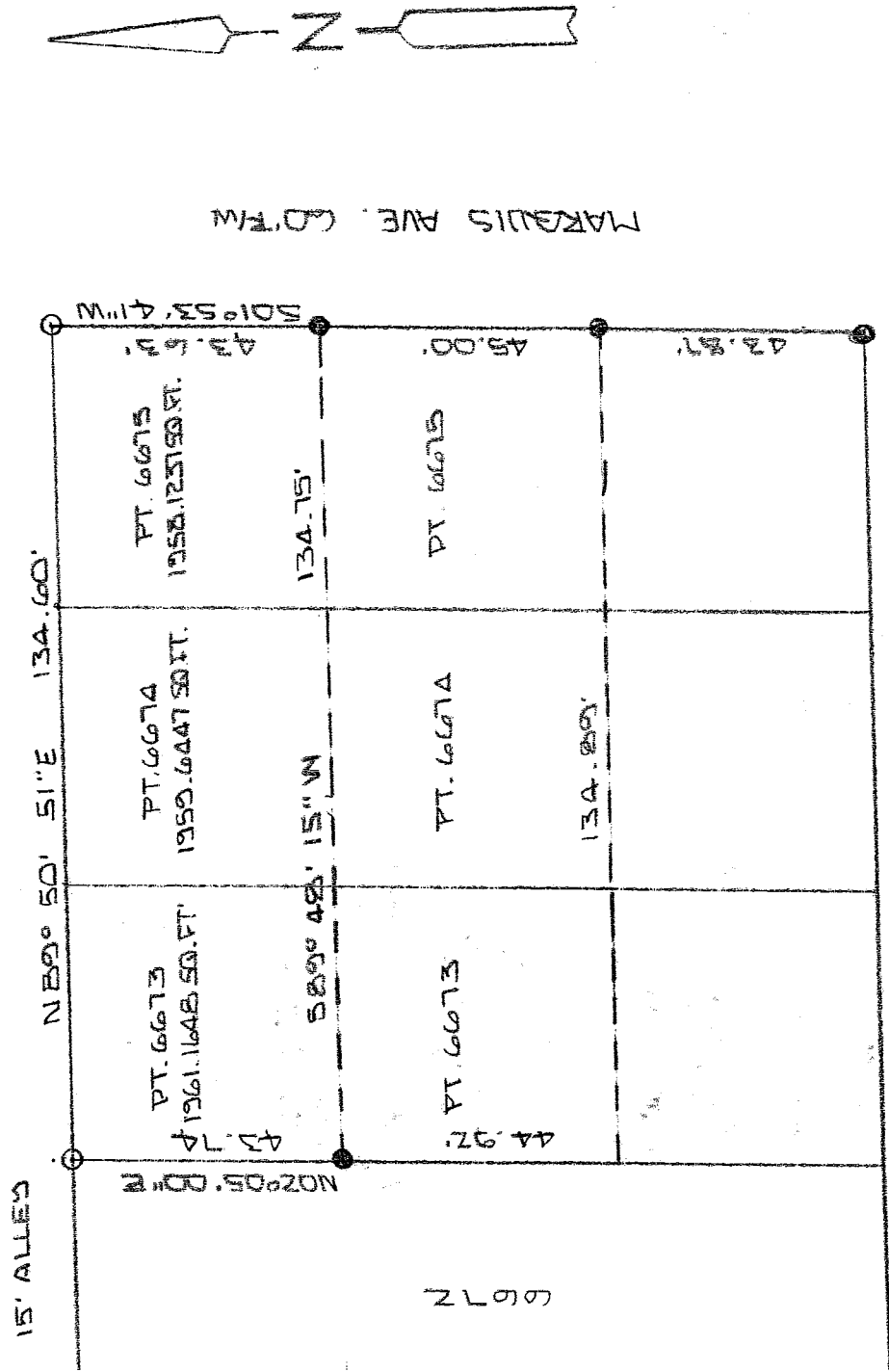

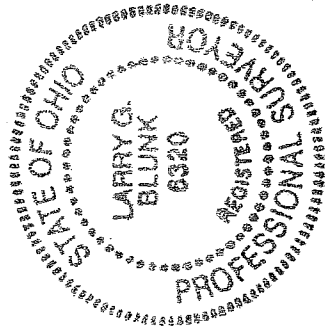

Located in the City of Mansfield, County of Richland, State of Ohio and being a part of Lot Numbers 6673, 6674 and 6675 and more particularly described as follows:

Beginning at an iron pin set in the Northeast Corner of Lot Number 6675.

Thence S 01 degrees 53' 41" W along the east line of Lot Number 6675 a distance of 43.63 feet to an iron pin found.

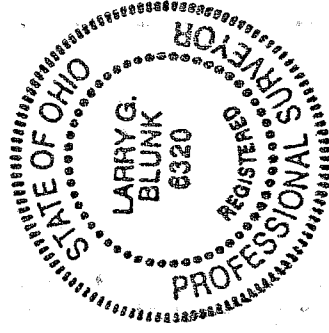
Thence S 89 degrees 48' 15" W a distance of 134.75 feet to an iron pin found on the west line of Lot Number 6673.

Thence N 02 degrees 05' 00" E along the west line of Lot Number 6673 a distance of 43.74 feet to an iron pin set in the Northwest Corner of Lot Number 6673.

Thence N 89 degrees 50' 51" E along the north line of Lot Numbers 6673, 6674 and 6675 a distance of 134.60 feet to the place of beginning and containing 5878.9332 square feet in all of which 1961.1648 square feet are in a part of Lot Number 6673, 1959.6447 square feet are in a part of Lot Number 6674 and 1958.1237 square feet are in a part of Lot Number 6675 but subject to all legal highways also all easements of record.
