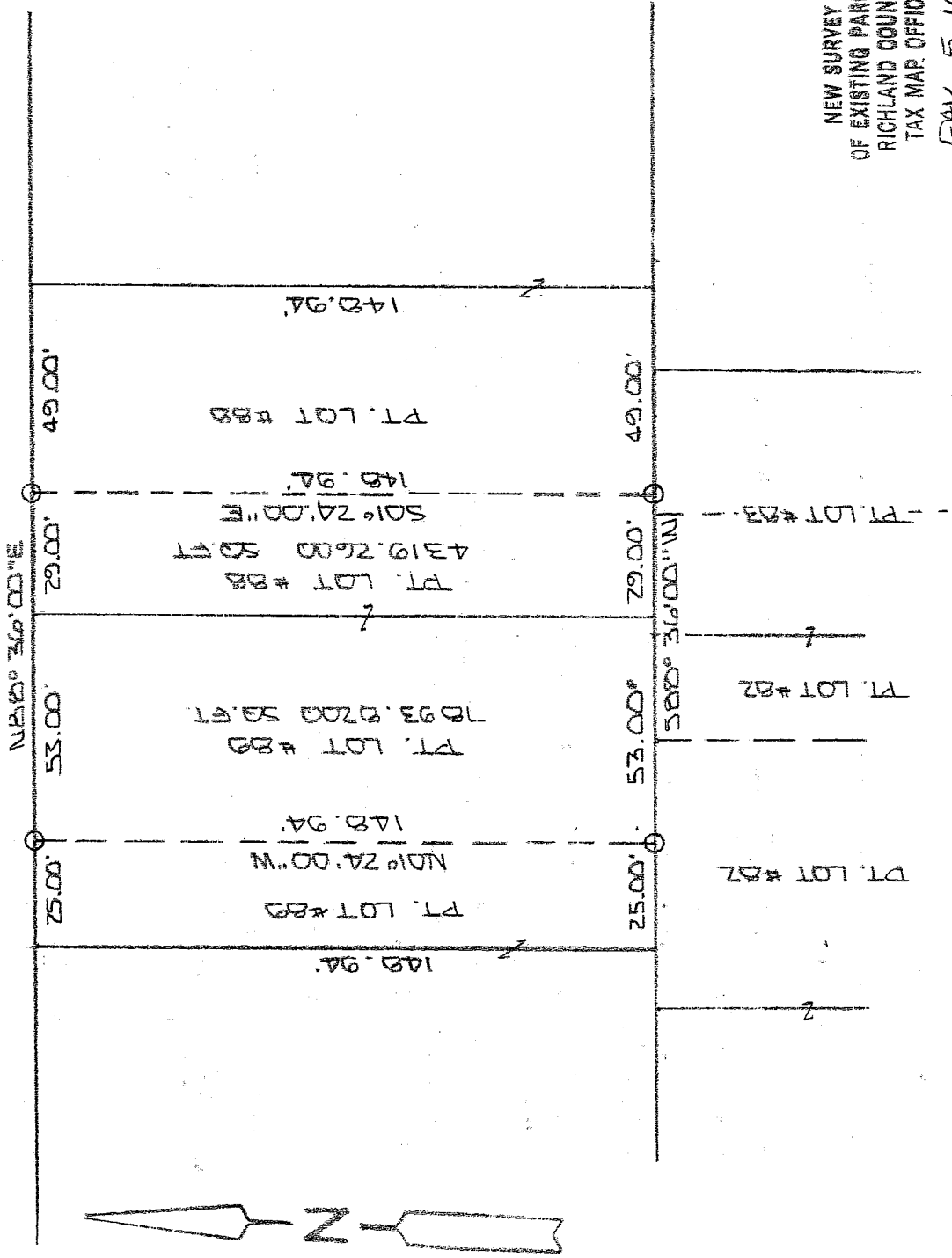

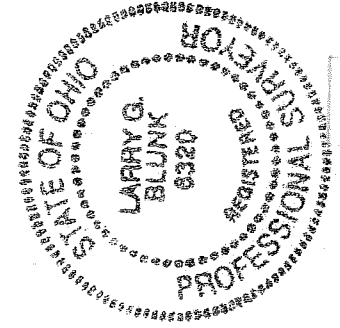

FOR

Located in the Township of Madison, County of Richland, State of Ohio and being a part of Lot Numbers 88 and 89 of Harprest Heights No. 4 as recorded in Volume 20, Page 54 of the Richland county Plat Records and more particularly described as follows:

Beginning at the Northwest Corner of Lot Number 88, referenced by an iron pin set N 88 degrees 36' 00" E - 29.00 feet.

Thence N 88 degrees 36' 00" E along the north line of Lot Number 88 a distance of 29.00 feet to an iron pin set.

Thence S 01 degrees 24' 00" E a distance of 148.94 feet to an iron pin set on the south line of Lot Number 88.

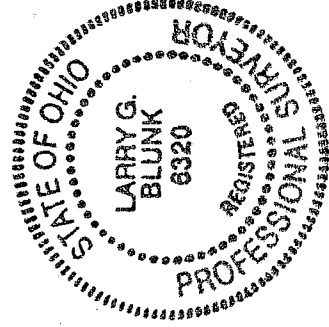
Thence S 88 degrees 36' 00" W along the south line of Lot Numbers 88 and 89 a distance of 82.00 feet to an iron pin set.

Thence N 01 degrees 24' 00" W a distance of 148.94 feet to an iron pin set on the north line of Lot Number 89.

Thence N 88 degrees 36' 00" E along the north line of Lot Number 89 a distance of 53.00 feet to the place of beginning and containing 12213.08 square feet in all of which 4319.2600 square feet are in a part of Lot Number 88 and 7893.82 square feet are in a part of Lot Number 89 but subject to all legal highways also all easements of record.
