

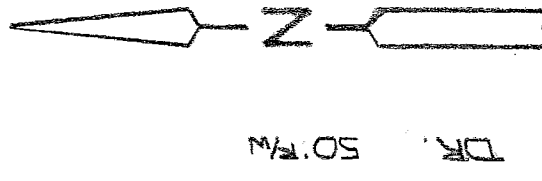
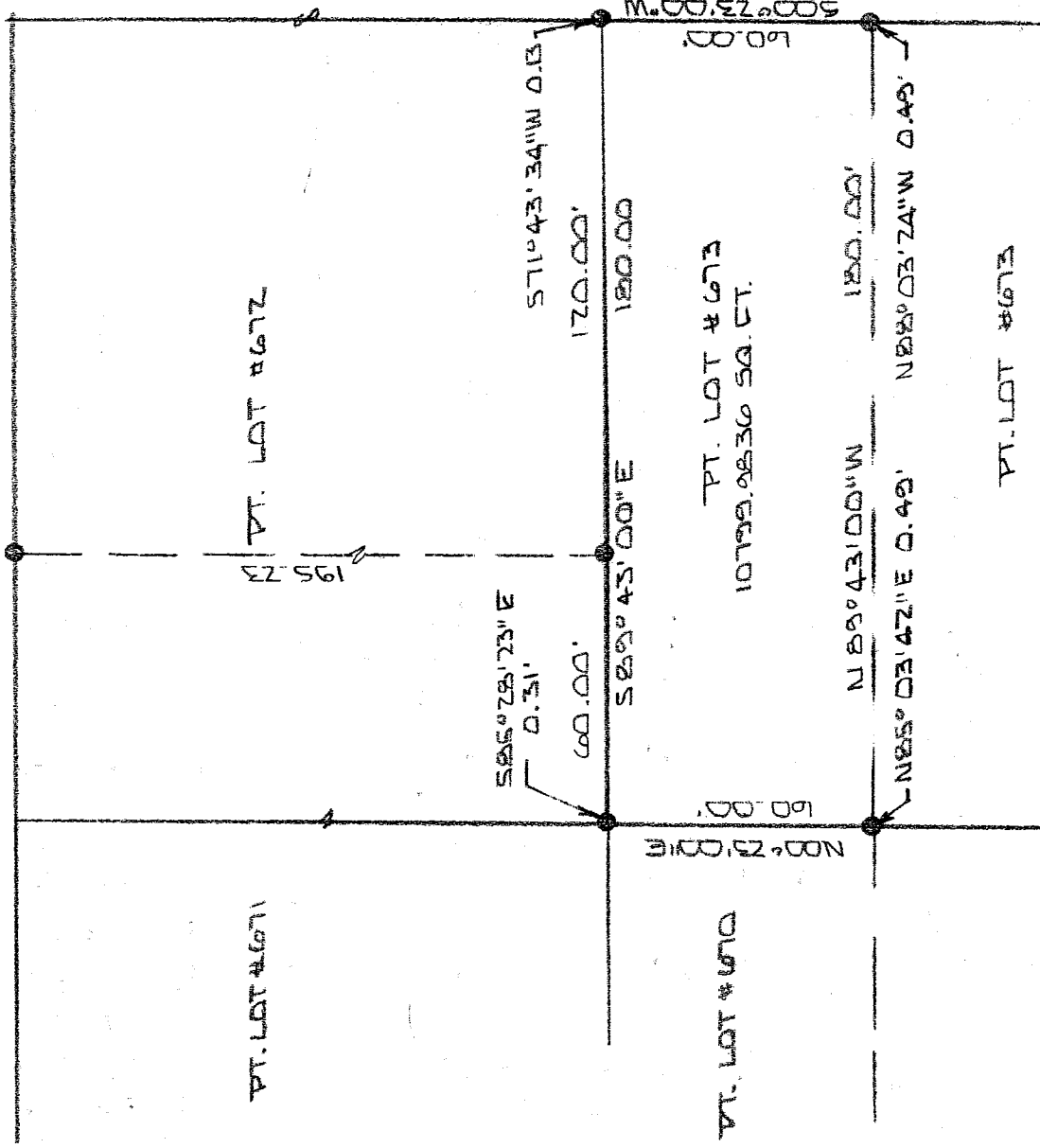

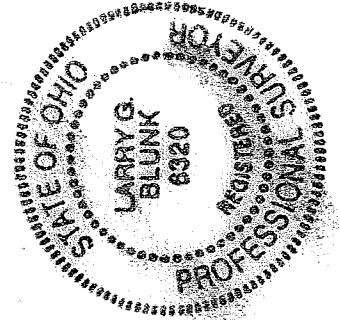

Located in the City of Ontario, County of Richland, State of Ohio and being a part of Lot Number 673 as recorded in Volume 11, Page 17 of the Richland County Plat Records and more particularly described as follows:

Beginning at the Northeast Corner of Lot Number 673, referenced by an iron pin found S 71 degrees 43' 34" W - 0.13 feet.


Thence S 00 degrees 23' 00" W along the east line of Lot Number 673 a distance of 60.00 feet, referenced by an iron pin found N 88 degrees 03' 24" W - 0.49 feet.

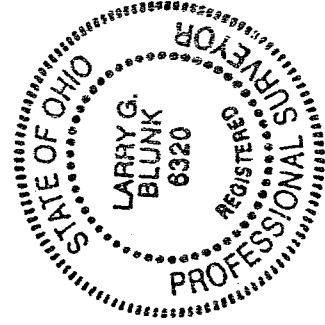
Thence N 89 degrees 43' 00" W a distance of 180.00 feet to the west line of Lot Number 673, referenced by an iron pin found N 85 degrees 03' 42" E - 0.49 feet.

Thence N 00 degrees 23' 00" E along the west line of Lot Number 673 a distance of 60.00 feet to the Northwest Corner of Lot Number 673, referenced by an iron pin found S 85 degrees 28' 23" E - 0.31 feet.

Thence S 89 degrees 43' 00" E along the north line of Lot Number 673 a distance of 180.00 feet to the place of beginning and containing 10799.9836 square feet but subject to all legal highways also all easements of record.
