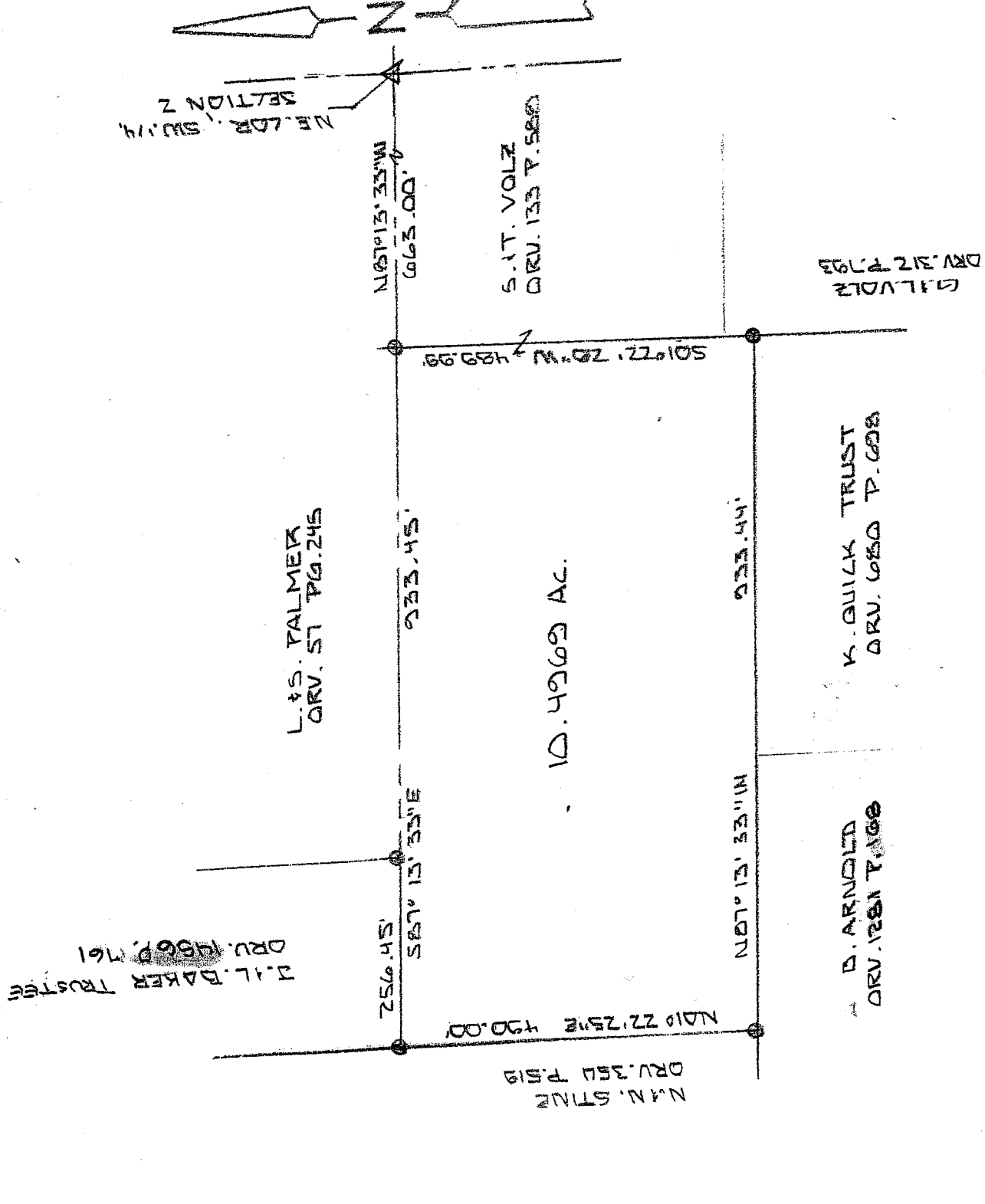


PLAT OF SURVEY FOR SHAWN VOLZ

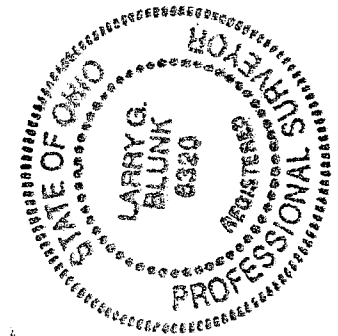

Located in the Township of Troy, County of Richland, State of Ohio and being a part of the Southwest Quarter of Section 2, Township 20, Range 19 and more particularly described as follows:

Beginning at a pk nail found in the Northeast Corner of the Southwest Quarter of Section 2.

Thence N 87 degrees 13' 33" W along the north line of the Southwest Quarter of Section 2 a distance of 663.00 feet to an iron pin found and the True Place of Beginning.

Thence S 01 degrees 22' 28" W a distance of 489.99 feet to an iron pin found.

Thence N 87 degrees 13' 33" W a distance of 933.44 feet to an iron pin found.

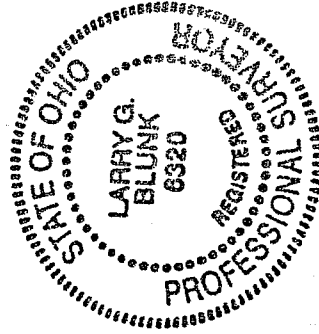
Thence N 01 degrees 22' 25" E a distance of 490.00 feet to an iron pin found.

Thence S 87 degrees 13' 33" E passing thru an iron pin found at 256.45 feet a total distance of 933.45 feet to the True Place of Beginning and containing 10.4969 acres more or less but subject to all legal highways also all easements of record.
