

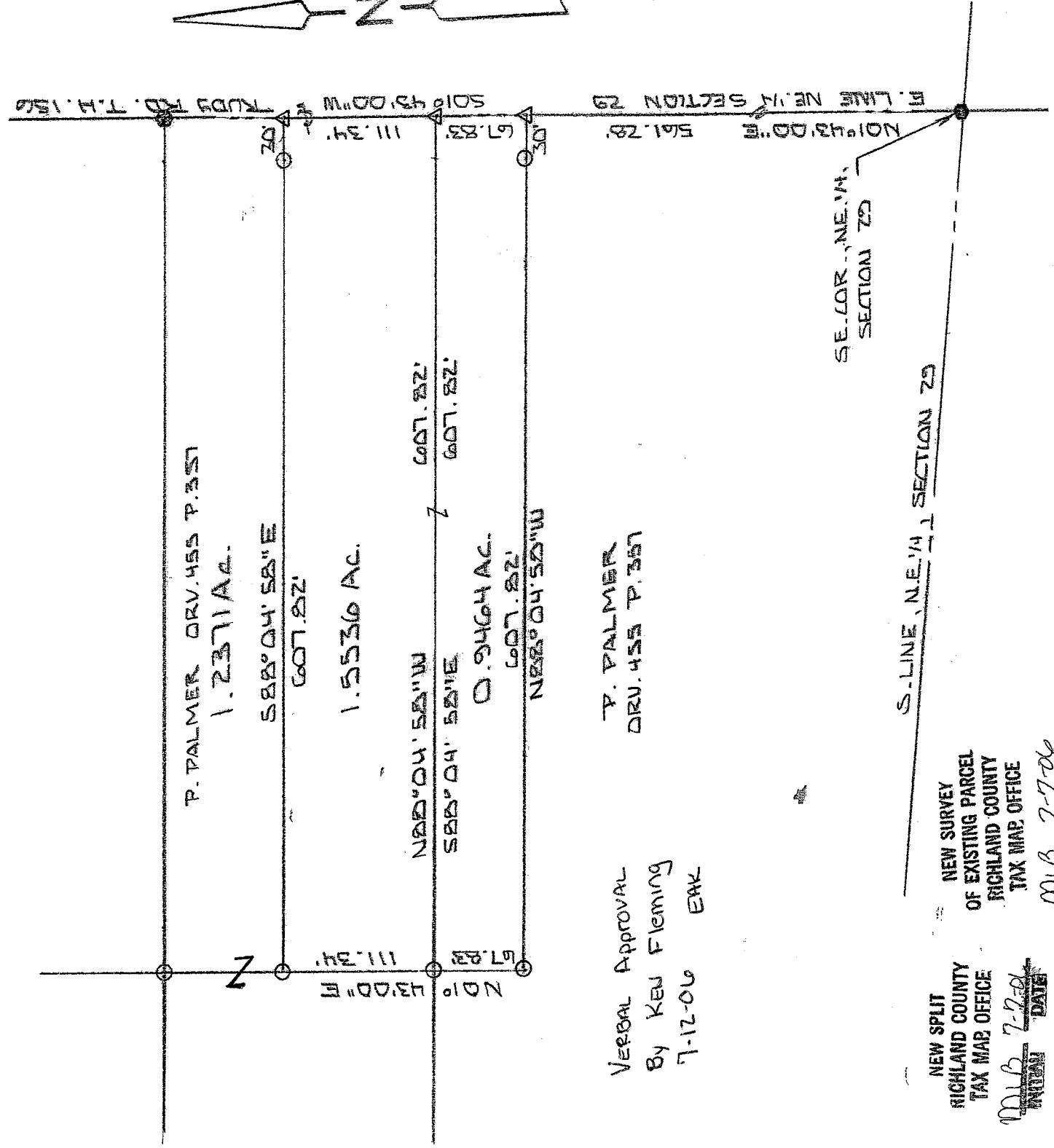

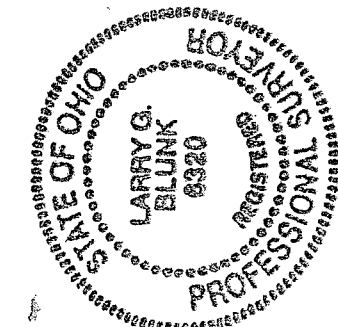

Thence N 01 degrees 43' 00" E a distance of 111.34 feet to an iron pin set.

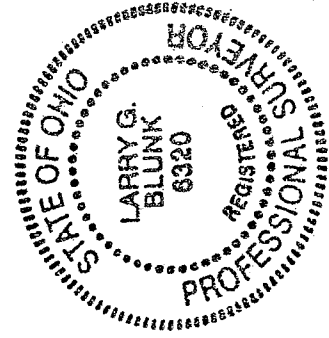

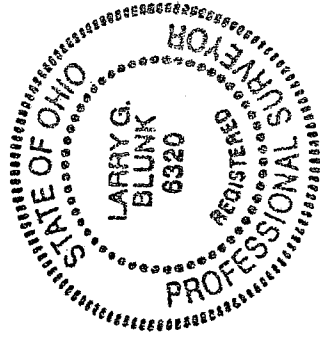

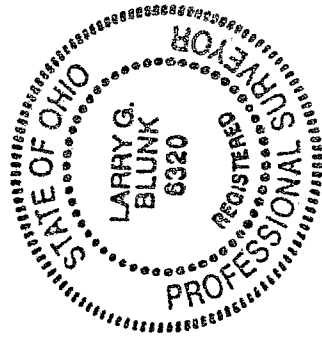
