Being part of Inlot 15124 of the new and revised numbers of the City of Mansfield, County of Richland, State of Ohio and being more fully described as follows:

Beginning at a 5/8 inch rebar set at the intersection of the South line of Longview Avenue with the East line of Inlot 15124;

thence running South 00 deg. 15 min. 05 sec. West along the East line of Inlot 15124 for 197.55 feet (a 5/8 inch rebar set South 00 deg. 15 min. 05 sec. West and 2.00 feet from this point);

thence turning and running South 73 deg. 30 min. 30 sec. West along the existing right-of-way of U.S.R. 30 for 187.55 feet to a 5/8 inch rebar set;

thence turning and running North 01 deg. 05 min. 01 sec. West for 126.32 feet (an existing iron pin being South 89 deg. 57 min. 00 sec. West and 10.00 feet from this point);

thence turning and running North 89 deg. 57 min. 00 sec. East for 70.00 feet to a 5/8 inch rebar set;

thence turning and running North 01 deg. 01 min. 29 sec. West for 124.58 feet to a 5/8 inch rebar set on the South line of Longview Avenue;

thence turning and running South 89 deg. 56 min. 04 sec. East along said South line for 115.32 feet to the place of beginning.

All 5/8 inch rebars set have a plastic cap stamped "PS 7016".
