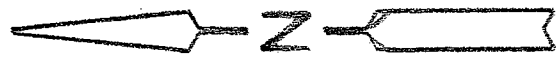
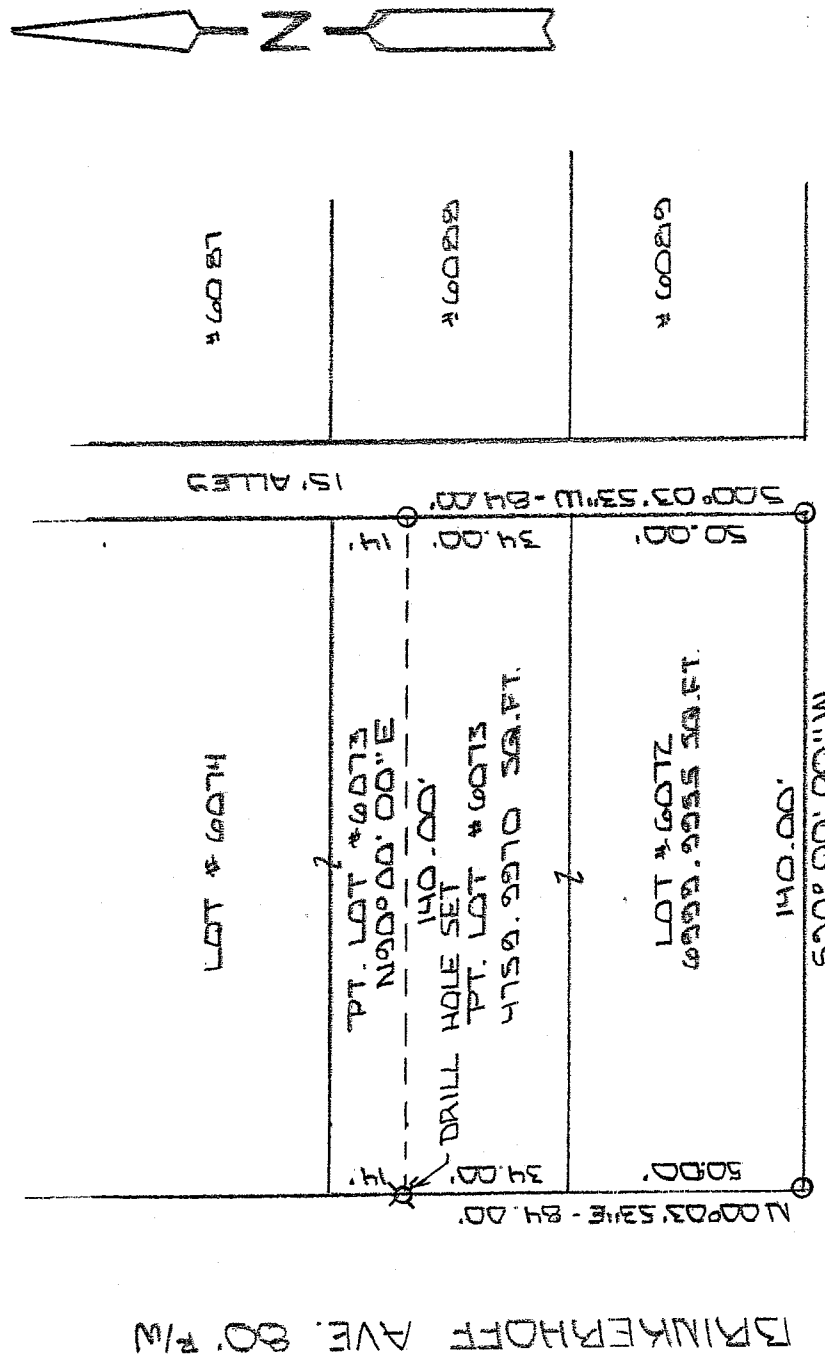


# PLAT OF SURVEY FOR DEBRA L. HOFARCE, EXECUTOR, ETC.

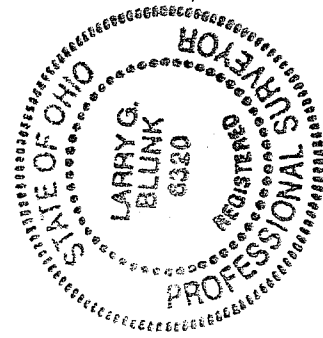

Thence N 00 degrees 03' 53" E along the west line of Lot Numbers 6072 and 6073 a distance of 84.00 feet to drill hole set.

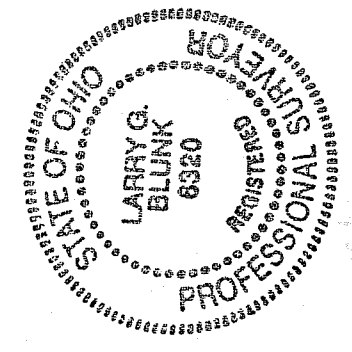
Thence N 90 degrees 00' 00" E a distance of 140.00 feet to an iron pin set on the east line of Lot Number 6073.
