

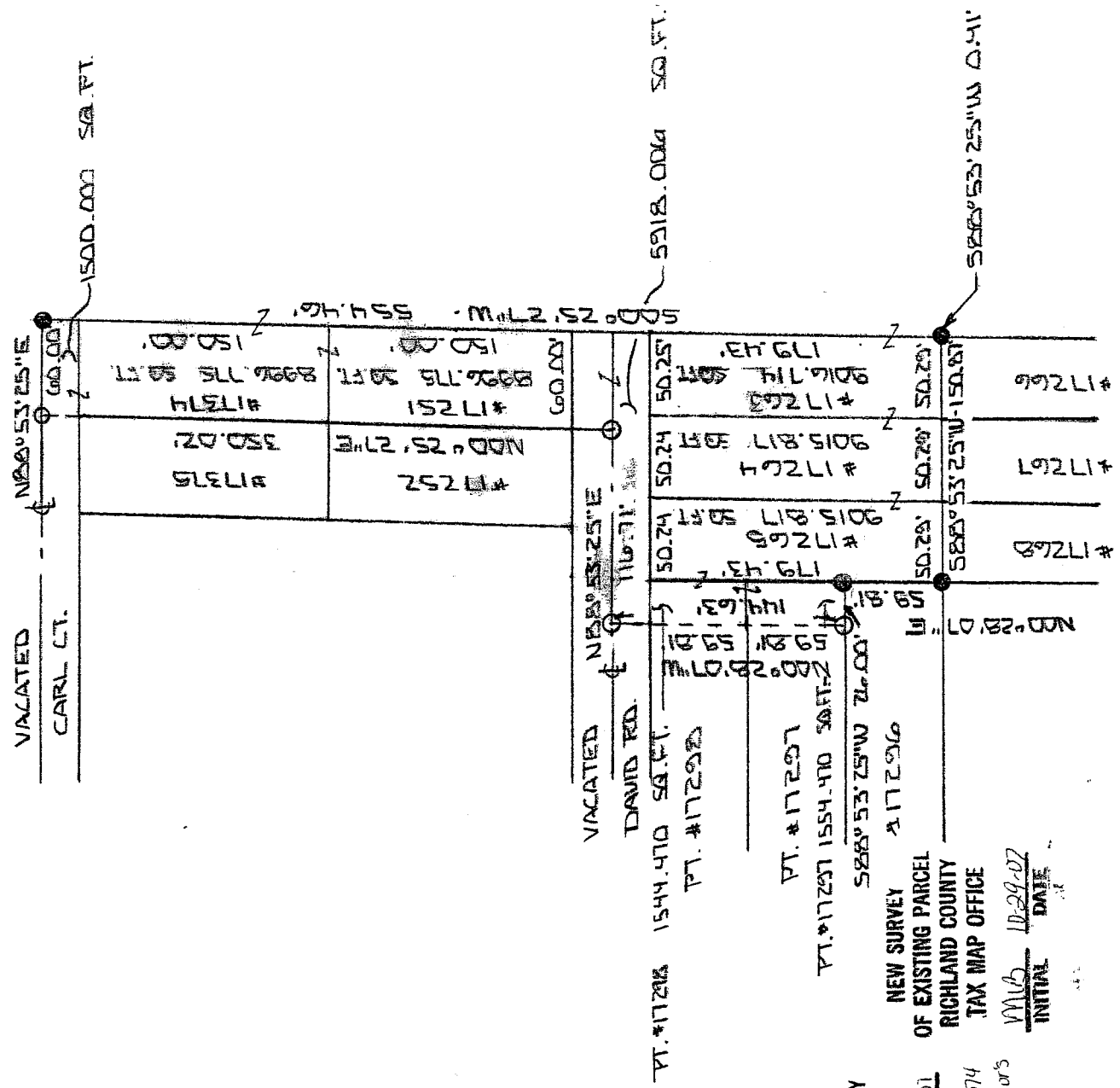
# PLAT OF SURVEY FOR MANSFIELD FIRE RECREATION CLUB

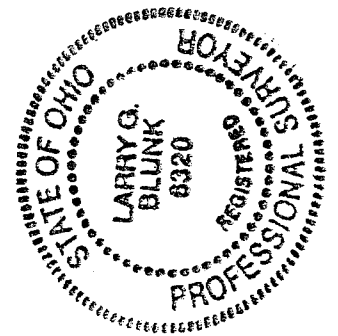

FOR  
MANSFIELD FIRE DEPARTMENT  
RECREATION CLUB**

Located in the City of Mansfield, County of Richland, State of Ohio and being Lot Numbers 17251, 17263, 17264, 17265, 17374 and a part of Lot Numbers 17297 and 17298 and a part of vacated Carl Court and a part of vacated David Rd. as recorded in Volume 16, Page 20 of the Richland County Plat Records and more particularly described as follows:

Beginning at the Southeast Corner of Lot Number 17263, referenced by an iron pin found S 88 degrees 53' 25" W - 0.41 feet.

Thence S 88 degrees 53' 25" W along the south line of Lot Numbers 17263, 17264 and 17265 a distance of 150.87 feet to an iron pin found in the Southwest Corner of Lot Number 17265.

Thence N 00 degrees 28' 07" E along the west line of Lot Number 17265 a distance of 59.81 feet to an iron pin found in the Southeast Corner of Lot Number 17297.

Thence S 88 degrees 53' 25" W along the south line of Lot Number 17297 a distance of 26.00 feet to an iron pin set.

Thence N 00 degrees 28' 07" E a distance of 144.63 feet to an iron pin set in the centerline of vacated David Rd..

Thence N 88 degrees 53' 25" E along the centerline of vacated David Rd. a distance of 116.71 feet to an iron pin set.

Thence N 00 degrees 25' 27" E a distance of 350.02 feet to an iron pin set in the centerline of vacated Carl Court.

Thence N 88 degrees 53' 25" E along the centerline of vacated Carl Court a distance of 60.00 feet to an iron pin found.

Thence S 00 degrees 25' 27" W a distance of 554.46 feet to the place of beginning and containing 55568.844 square feet in all of which 8996.775 square feet is in Lot Number 17251, 8996.775 square feet is in Lot Number 17374, 9016.714 square feet is in Lot Number 17263, 9015.817 square feet is in Lot Number 17264, 9015.817 square feet is in Lot Number 17265, 1554.470 square feet is in a part of Lot Number 17297, 1554.470 square feet is in a part of Lot Number 17298, 5918.006 square feet is in a part of vacated David Rd. and 1500.000 square feet is in a part of vacated Carl Court but subject to all legal highways also all easements of record.
