LEGAL DESCRIPTION THOMAS L. DURBIN LOT SPLIT 0.485 ACRE

Situated in the City of Ontario, County of Richland, State of Ohio and being part of the Southeast Quarter of Section 20, Township 21 North, Range 19 West and more particularly described as follows:

Beginning for the same at a ³/₄" iron pipe found marking the southeast corner of Lot 2697 of the consecutively numbered lots in the Shangri-La Subdivision as recorded in Plat Volume 27, Pg. 1 of the Richland County Records;

- thence S87°38'08"E, a distance of 202.20 feet along the south property lines of land conveyed to Douglas P. Sloboda and Kimberly L. Sloboda by O.R.V. 1451, Pg. 367 of the Richland County Records and land conveyed to Bobby J. Minard and Marilyn K. Minard by O.R.V. 1728, Pg. 44 of the Richland County Records to a ³/₄" iron pipe found;
- 2) thence S3°20'08"E, a distance of 104.86 feet along the west property line of land conveyed to Terrence Alan Miller and Elizabeth Ann Miller by D.V. 855, Pg. 804 of the Richland County Records to a survey marker set;
- 3) thence N87°38'08"W, a distance of 202/82 feet to a 5/8" rebar found on an east property line for the Shangri-La Subdivision as recorded in Plat Volume 27, Pg. 1 of the Richland County Records;
- 4) thence N2°59'52"W, a distance of 104.80 feet along said east property line of the Shangri-La Subdivision to the Principal Point of Beginning, enclosing an area of 0.485 acre, more or less, and subject to all legal easements, use restrictions and public right of way now on record.
