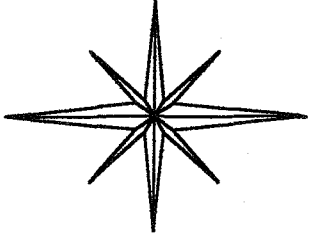


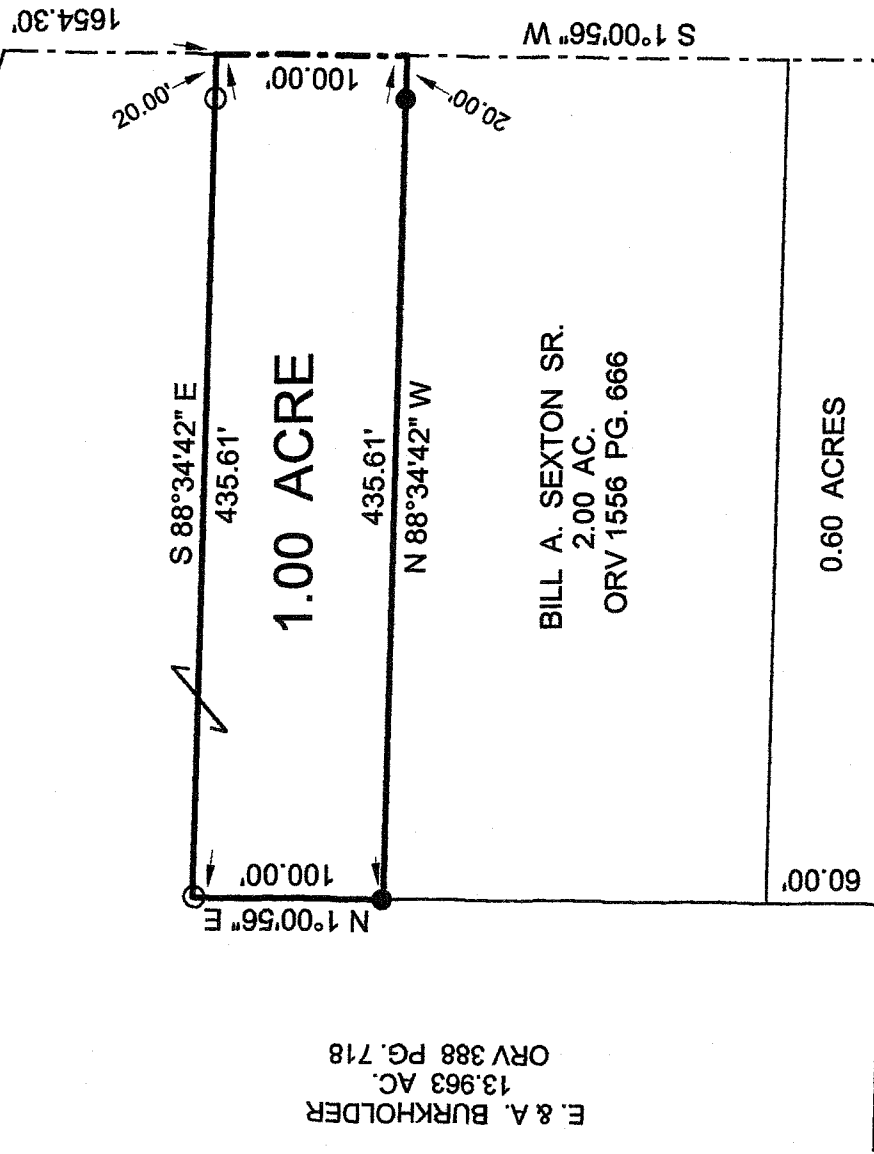

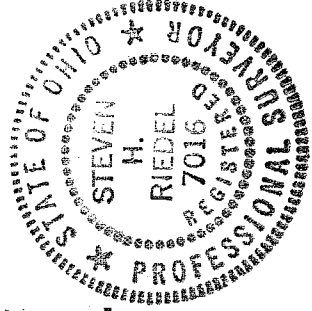

Situated in the Township of Cass, County of Richland, State of Ohio and being part of the Northeast quarter of Section 3, T-23, R-19 and being more fully described as follows:

Commencing at an existing survey nail at the intersection of the centerline of County Highway 11 (Base Line Road, also being the North line of Section 3) with the centerline of Township Highway 69 (Barnes Road);

thence running South 01 deg. 00 min. 56 sec. West along the centerline of Township Highway 69 for 1654.30 feet to the place of beginning (a 5/8 inch rebar being set North 88 deg. 34 min. 42 sec. West and 20.00 feet from this point);

thence continuing South 01 deg. 00 min. 56 sec. West along said centerline for 100.00 feet;

thence turning and running North 88 deg. 34 min. 42 sec. West (passing an existing iron pin at 20.00 feet) for a total distance of 435.61 feet to an existing iron pin;

thence turning and running North 01 deg. 00 min. 56 sec. East for 100.00 feet to a 5/8 inch rebar set;

thence turning and running South 88 deg. 34 min. 42 sec. East (passing a 5/8 inch rebar set at 415.61 feet) for a total distance of 435.61 feet to the place of beginning.

All 5/8 inch rebars set have a plastic cap stamped "PS 7016".

The above described parcel has a calculated area of 1.00 acres of land according to a survey made on April 28, 2008 by Steven H. Riedel, Ohio surveyor 7016.
