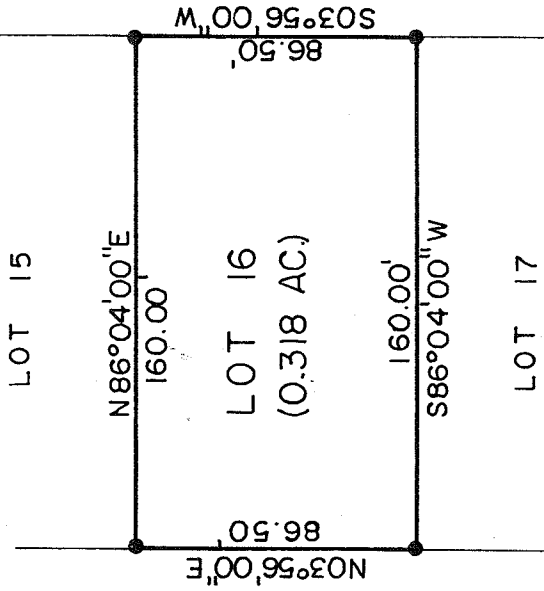
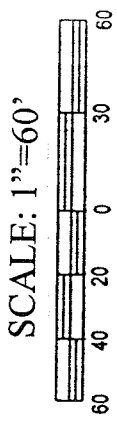
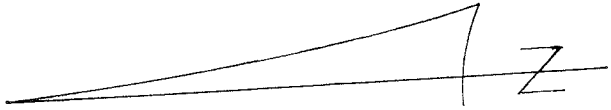


PLAT OF PROPERTY SURVEY

SANDUSKY TOWNSHIP, RICHLAND COUNTY, OHIO



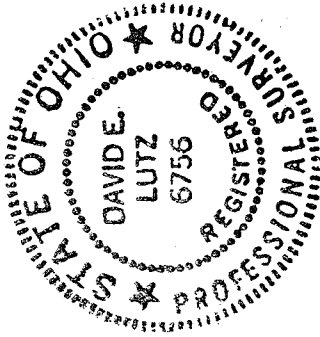

DESCRIPTION: Being Lot 16, Schonrose Allotment, Sandusky Township, Richland County, Ohio, and being more particularly described as follows;


Beginning for the same at an iron pin set at the northeast corner of Lot 16 on the west right-of-way of Crestview Drive, which is the real point of beginning of the parcel herein described;

- 1.) thence S03°56'00"W a distance of 86.50 feet along said west right-of-way, to an iron pin set at the southeast corner of Lot 16;
- 2.) thence S86°04'00"W a distance of 160.00 feet along the south line of Lot 16 to an iron pin set at the southwest corner of Lot 16;
- 3.) thence N03°56'00"E a distance of 86.50 feet along the west line of Lot 16 to an iron pin set at the northwest corner of Lot 16;
- 4.) thence N86°04'00"E a distance of 160.00 feet along the north line of Lot 16 to the iron pin set at the real point of beginning;

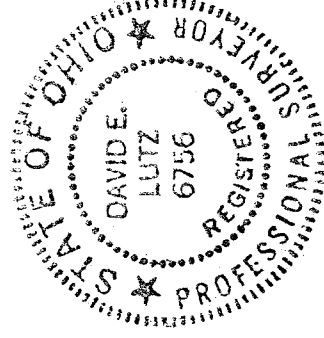
