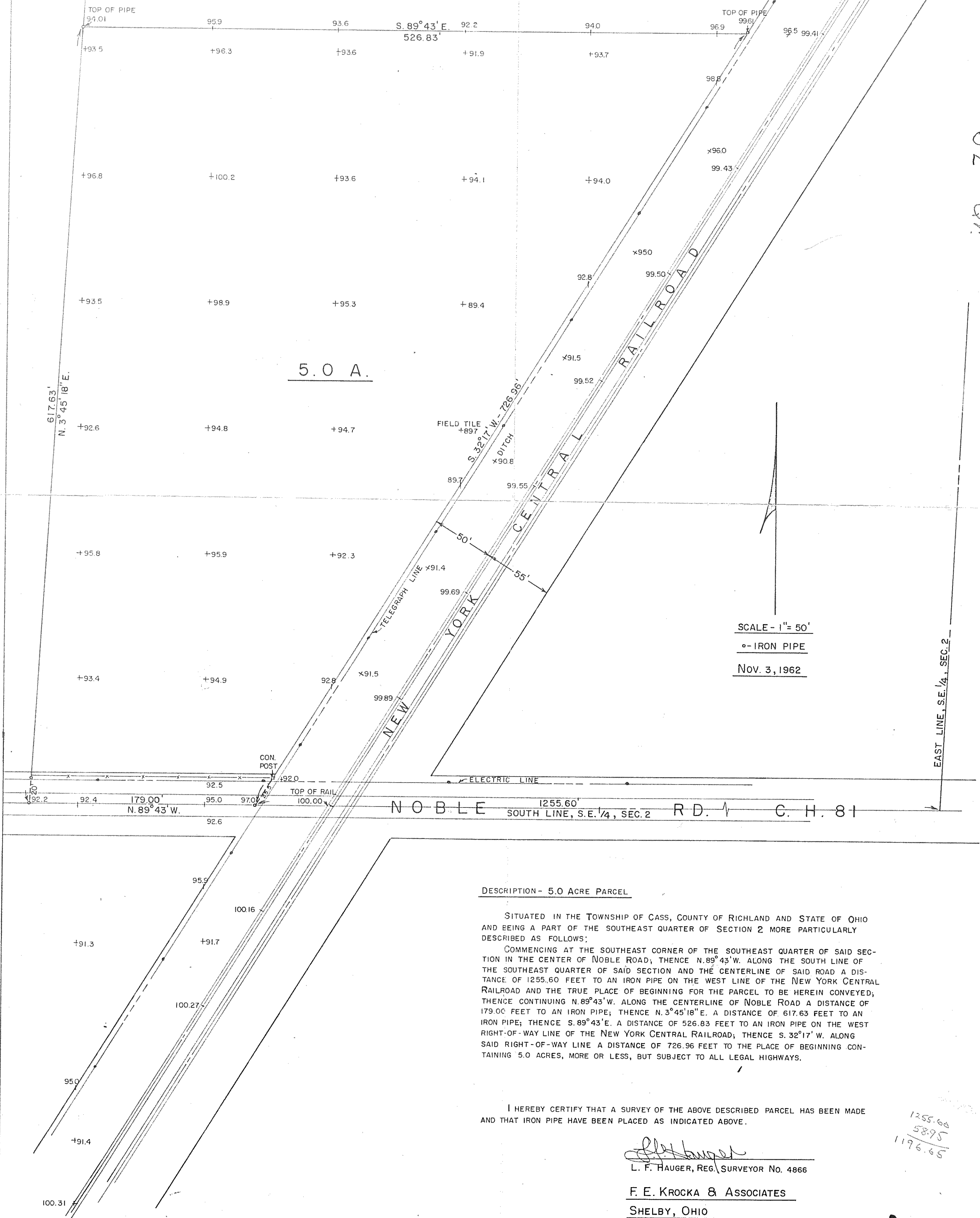

DESCRIPTION - 5.0 ACRE PARCEL

SITUATED IN THE TOWNSHIP OF CASS, COUNTY OF RICHLAND AND STATE OF OHIO AND BEING A PART OF THE SOUTHEAST QUARTER OF SECTION 2 MORE PARTICULARLY DESCRIBED AS FOLLOWS:
 COMMENCING AT THE SOUTHEAST CORNER OF THE SOUTHEAST QUARTER OF SAID SECTION IN THE CENTER OF NOBLE ROAD; THENCE N. 89° 43' W. ALONG THE SOUTH LINE OF THE SOUTHEAST QUARTER OF SAID SECTION AND THE CENTERLINE OF SAID ROAD A DISTANCE OF 1255.60 FEET TO AN IRON PIPE ON THE WEST LINE OF THE NEW YORK CENTRAL RAILROAD AND THE TRUE PLACE OF BEGINNING FOR THE PARCEL TO BE HEREIN CONVEYED; THENCE CONTINUING N. 89° 43' W. ALONG THE CENTERLINE OF NOBLE ROAD A DISTANCE OF 179.00 FEET TO AN IRON PIPE; THENCE N. 3° 45' 18" E. A DISTANCE OF 617.63 FEET TO AN IRON PIPE; THENCE S. 89° 43' E. A DISTANCE OF 526.83 FEET TO AN IRON PIPE ON THE WEST RIGHT-OF-WAY LINE OF THE NEW YORK CENTRAL RAILROAD; THENCE S. 32° 17' W. ALONG SAID RIGHT-OF-WAY LINE A DISTANCE OF 726.96 FEET TO THE PLACE OF BEGINNING CONTAINING 5.0 ACRES, MORE OR LESS, BUT SUBJECT TO ALL LEGAL HIGHWAYS.
