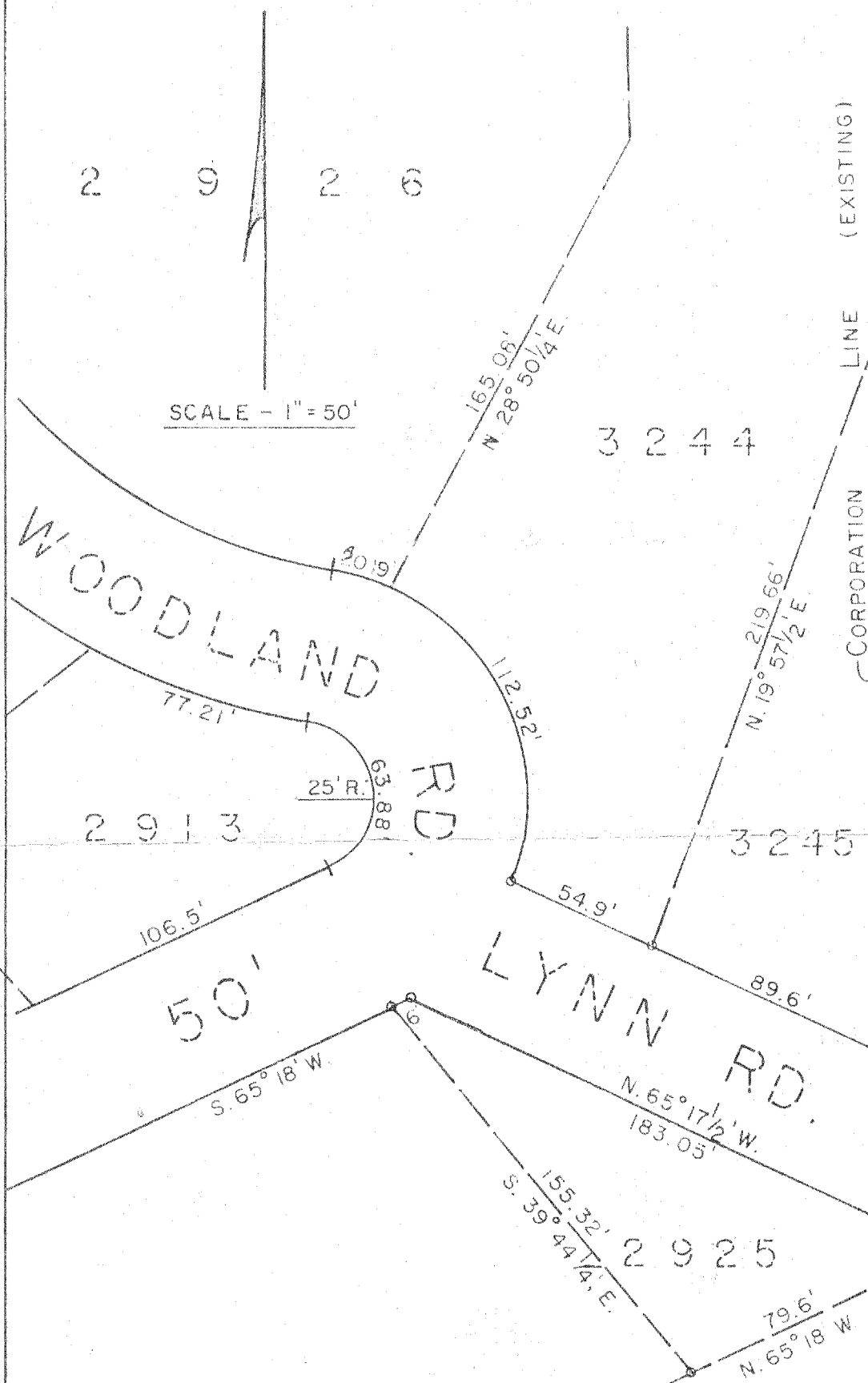


**ANNEXATION TO SHELBY  
PT. OF S.W. 1/4, SEC. 9 - JACKSON TWP.  
&  
DEDICATION (EXTENSION) OF  
LYNN ROAD**



**LEGAL DESCRIPTION**

SITUATED IN THE TOWNSHIP OF JACKSON, COUNTY OF RICHLAND AND STATE OF OHIO AND BEING PART OF THE SOUTHWEST QUARTER OF SECTION 9, BOUNDED AND DESCRIBED AS FOLLOWS:  
BEGINNING AT AN IRON PIPE ON THE CORPORATION LINE OF SHELBY ON THE NORTH LINE OF LYNN ROAD AT THE SOUTHEAST CORNER OF LOT 3245 IN THE CITY OF SHELBY; THENCE S. 1° 30 1/2' E. ALONG THE CORPORATION LINE A DISTANCE OF 326.17 FEET TO A CONCRETE MONUMENT, THENCE N. 64° 27 1/2' E. A DISTANCE OF 220.59 FEET TO AN IRON PIPE; THENCE N. 1° 54 1/4' W. A DISTANCE OF 214.08 FEET TO AN IRON PIPE; THENCE N. 26° 26' W. A DISTANCE OF 50.31 FEET TO AN IRON PIPE; THENCE S. 69° 59 1/2' W. A DISTANCE OF 91.69 FEET TO AN IRON PIPE; THENCE S. 88° 29 1/2' W. A DISTANCE OF 80.21 FEET TO AN IRON PIPE; THENCE N. 65° 17 1/2' W. A DISTANCE OF 12.97 FEET TO THE PLACE OF BEGINNING CONTAINING 1.41 ACRES.
