DESCRIPTION - Parcel No. 1 Being part of the Northeast Quarter of Section Twenty-six (26), Township Twenty-two (22), Range Nineteen (19), Jackson Township, Richland County, Ohio and being more particularly described as follows: Beginning for the same at an iron pipe in the centerline of Meyers Road (County Highway No. 201) which iron pipe is the Northeast Corner of Section twenty-six (26); thence due West along the centerline of Meyers Road (north line of section twenty-six (26), a distance of 333.00 feet to a point; thence S 0°22' E on a line parallel to the east line of said Section a distance of 521.67 feet to an iron pipe which is the real point of beginning of the parcel herein described; thence continuing S 0°22' E on a line parallel to the east section line a distance of 529.68 feet to an iron pipe; thence S 89°36' W a distance of 663.83 feet to an iron pipe; thence N 0°24' W a distance of 534.33 feet to an iron pipe; thence due East on a line parallel to the north Section line a distance of 664.17 feet to an iron pipe which is the real point of beginning and containing 8.11 acres more or less but subject to all legal easements now on record.

DESCRIPTION - Parcel No. 2 Being part of the Northeast Quarter of Section Twenty-six (26), Township twenty-two (22), Range Nineteen (19), Jackson Township, Richland County, Ohio and being more particularly described as follows: Beginning for the same at an iron pipe in the centerline of Meyers Road (County Highway No. 201) which iron pipe is the Northeast Corner of Section twenty-six (26); thence due West along the centerline of Meyers Road (North line of Section Twenty-six (26), a distance of 333.00 feet to a point; thence S 0°22' E on a line parallel to the east line of said Section a distance of 1,051.35 feet to an iron pipe which is the real point of beginning of the parcel herein described; thence continuing S 0°22' E on a line parallel to the east section line a distance of 264.47 feet to an iron pipe; thence S 89°20'45" W a distance of 998.37 feet to an iron pipe which is 60.0 feet west of the centerline of the Springmill North Road (County Highway No. 208); thence N 0°24' W a distance of 268.88 feet to an iron pipe; thence N 89°36' E a distance of 998.51 feet to an iron pipe which is the real point of beginning and containing 6.11 acres more or less but subject to all legal easements and public right-of-ways now on record.
