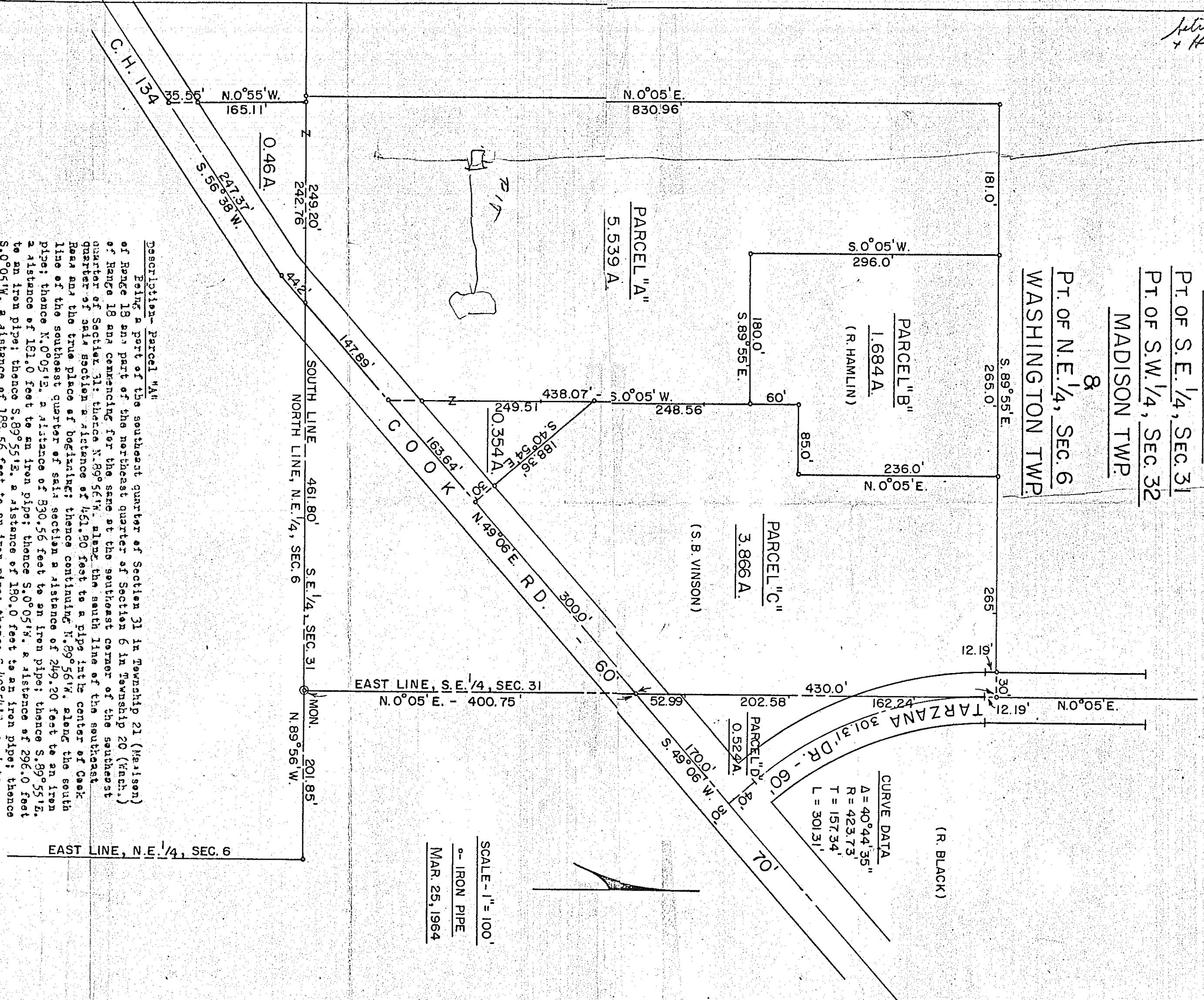

Description- Parcel "A"

Being a part of the southeast quarter of Section 31 in Township 21 (Madison) of Range 18 and commencing for the same at the southeast corner of the southeast quarter of Section 31; thence N. 89° 56' W., along the south line of the southeast quarter of said section a distance of 400.75 feet to an iron pipe in the center of Cook Road; thence the true place of beginning for the parcel to be herein conveyed; thence continuing N. 0° 05' E., along the west line of the southwest quarter of said section a distance of 417.81 feet to a point in the center of Tarzana Drive; thence on a curve to the left with a radius of 423.73 feet along the centerline of Tarzana Drive a distance of 301.31 feet to a point on the north line of Cook Road; thence S. 40° 54' E., a distance of 40 feet to the center of Cook Road; thence S. 49° 06' W., along the centerline of Cook Road a distance of 170.0 feet to the place of beginning containing 0.524 acres, more or less but subject to all legal highways, containing in all 5.999 acres.

Description- Parcel "B"

Being a part of the southwest quarter of Section 32 in Township 21 (Madison) of Range 18 and commencing for the same at the southwest corner of the southwest quarter of said section; thence N. 0° 05' E., along the west line of the southwest quarter of said section a distance of 400.75 feet to an iron pipe in the center of Cook Road and the true place of beginning for the parcel to be herein conveyed; thence continuing N. 0° 05' E., along the west line of the southwest quarter of said section a distance of 417.81 feet to a point in the center of Tarzana Drive; thence on a curve to the left with a radius of 423.73 feet along the centerline of Tarzana Drive a distance of 301.31 feet to a point on the north line of Cook Road; thence S. 40° 54' E., a distance of 40 feet to the center of Cook Road; thence S. 49° 06' W., along the centerline of Cook Road a distance of 170.0 feet to the place of beginning containing 0.524 acres, more or less but subject to all legal highways.

Description- Parcel "C"

Being a part of the southeast quarter of Section 31 in Township 21 (Madison) of Range 18 and commencing for the same at the southeast corner of the southeast quarter of said section; thence N. 89° 56' W., along the south line of the southeast quarter of said section a distance of 461.80 feet to an iron pipe in the center of Cook Road; thence N. 49° 06' E., along the centerline of Cook Road a distance of 147.89 feet to an iron pipe; thence N. 0° 05' E., a distance of 249.51 feet to an iron pipe; thence S. 40° 54' E., a distance of 189.36 feet to an iron pipe in the center of Cook Road; thence S. 49° 06' W., along the centerline of Cook Road a distance of 163.64 feet to the place of beginning containing 0.354 acres, more or less, but subject to all legal highways.
