Grantees, their heirs and assigns do hereby covenant and agree that the parcel of land described in this instrument will not be conveyed by said grantees, heirs and assigns, unless said parcel fronts on a public highway or dedicated street, or is sold together with land fronting on a public highway or dedicated street.

Bearings are to an assumed meridian and are used to express angles only.

All iron pins set are 5/8" diameter reinforcing rod with plastic cap stamped "S.J.L. INC.".

## SURVEYOR'S DESCRIPTION FOR ERVIN JUHASF

PARCEL "A" (0.110 ACRES)

Situated in the Township of Mifflin, County of Richland, State of Ohio, being part of the Northwest Quarter of Section 17, Township 23, Range 17 and being more particularly described as follows:

Commencing at a railroad spike set in the northeast corner of said Northwest Quarter, said railroad spike also being in the centerline of Crider Road (C.H. 92);

Thence due south, 272.25 feet along the east line of said Northwest Quarter to an iron pin set in the south line of a parcel of land conveyed to Paraskeva Koleff by Volume 93, Page 317 of Richland County Official Records;

Thence due west, 38.10 feet along said south line of Paraskeva Koleff to an iron pin set in the southwest corner of said land of Paraskeva Koleff, said iron pin also being in the southeast corner of a parcel of land conveyed to Ervin Juhasf and Elizabeth Harie Koleff by Volume 787, Page 237 of Richland County Deed Records and the true place of beginning;

Thence due south, 31.81 feet to an iron pin set in a north line of a parcel of land conveyed to Rodney L. and Jan B. Penrose by Volume 909, Page 608 of Richland County Deed Records;

Thence N 88° 39' 00" W, 160.04 feet along said north line of Rodney L. and Jan B. Penrose and said north line extended to an iron pin set;

Thence due north, 28.04 feet to an iron pin found in the southwest corner of said land of Ervin Juhasf and Elizabeth
