

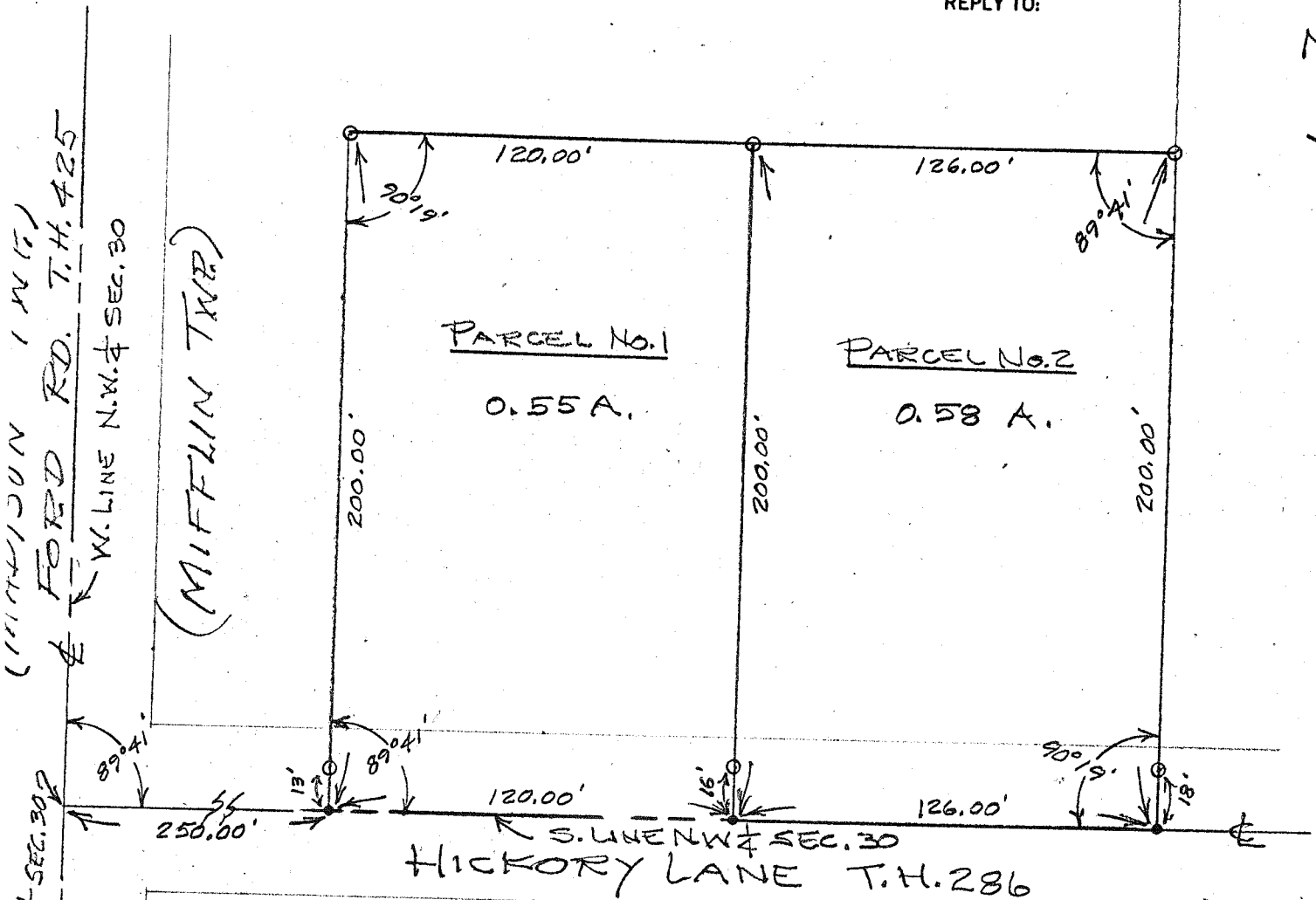

**ENGINEERING DESCRIPTION
FOR
VERN HARP**

PARCEL NO. 2

Located in Mifflin Township, Richland County, State of Ohio, and known as part of the northwest quarter of Section 30, Township 23, Range 17, and more particularly described as follows:

Commencing at the southwest corner of the northwest quarter of Section 30, being also the intersection of the centerlines of Ford Road (T.H. 425) and Hickory Lane (T.H. 286);

Thence easterly along the south line of said quarter section, a distance of 370.00 feet to the true place of beginning;

Thence northerly, parallel to the west line of said quarter section and with a deflection to the left of 89 degrees 41 minutes, a distance of 200.00 feet to an iron pin, passing through an iron pin at 16.00 feet;

Thence easterly, parallel to the south line of said quarter section and with an interior angle of 90 degrees 19 minutes, a distance of 126.00 feet to an iron pin;

Thence southerly, parallel to the west quarter section line, and with an interior angle of 89 degrees 41 minutes, a distance of 200.00 feet to the south line of the quarter section, passing through an iron pin at 182.00 feet;

Thence westerly, along the south line of the quarter section, a distance of 126.00 feet to the place of beginning, containing 0.58 acres, more or less, but subject to all legal highways and easements of record.
